**NOTICE OF PUBLIC HEARING ON THE APPROVAL BY THE CITY OF BISMARCK, NORTH DAKOTA ISSUING REVENUE BONDS FOR BAPTIST HOME, INC. TO FINANCE THE ACQUISITION OF LAND AND CONSTRUCTION, FURNISHING AND EQUIPPING OF A NURSING HOME**

NOTICE IS HEREBY GIVEN that the City of Bismarck, North Dakota (the "City") will conduct a public hearing on December 13, 2011 at 5:15 p.m. at City and County Office Building, 221 N. Fifth Street, Bismarck, North Dakota, for the purpose of conducting a public hearing for the proposal to issue revenue bonds of the City in an aggregate principal amount of not to exceed \$20,000,000 (the "Bonds") and to loan such amount to Baptist Home, Inc., or a related entity (the "Borrower") for the purposes of acquiring land and land improvements and constructing, equipping and furnishing a 140-bed nursing home to be located between Florida Drive, Nebraska Drive, Colorado Drive North and Montana Drive in Bismarck, North Dakota, and paying for costs of issuance and certain other costs associated with the issuance of the Bonds (the "Project").

The City has been authorized under North Dakota Century Code, Chapter 40-57 (the "Act") to finance nursing home facilities under the circumstances and within the limitations of the Act. The Act provides that such programs for nursing homes may be financed by revenue bonds issued by the City. The purpose of the public hearing will be to receive information on a proposal that the City approve the Bonds under the Act in order to permit the financing of the Project.

One or more cities or counties in North Dakota will be issuing the Bonds on behalf of the City pursuant to Joint Power Agreements and Allocations. The Bonds, as and when issued, will not constitute a charge, lien, or encumbrance upon any property of the City, or the city or county that is an issuer of the bonds, except the Project and the revenues to be derived from the Project. Such obligations will not be a charge against the general credit or taxing powers of the City, or the city or county that is an issuer of the bonds, but will be payable from sums to be paid by the Borrower pursuant to a revenue agreement.

A public hearing will be conducted by the Mayor of the City or some other person delegated to conduct the hearing by the Mayor. All persons interested may appear and be heard at the time and place set forth above or may file written comments with the Mayor of the City prior to the date of the hearing. The City is expected to meet and act on the final approval of the Bonds promptly upon completion of the hearing. At the time and place, oral or written objections from any resident or property owner of the Issuer may be presented. At such meeting or any adjournment thereof, the Issuer shall adopt a resolution determining whether or not to proceed with the issuance of the Bonds. Sitting Bull College will receive bids on **December 20, 2011** for the construction of the **NATIONAL NATIVE AMERICAN SCENIC BYWAY VISITOR INFORMATION SITES**. Separate sealed proposals for General construction, shall be delivered to the Sitting Bull College Science Building located at 9292 Highway 24, Fort Yates, North Dakota no later than **2:00 PM CT** at which time qualified submittals will be

publicly opened and read. Each bid shall be accompanied by a Bid Bond in the amount of (5%) of the Base Bid including deduct alternates and be made payable to Sitting Bull College. The bid bond shall be executed by the bidder as principal and having as surety a company licensed to do business in the state of North Dakota. Upon delivery of a contract to the successful bidder, the Contractor shall furnish a Payment & Performance Bonds each in (100%) of the contract amount to insure performance and material payments to all persons involved in construction on said project.

The sealed bid proposal envelope shall contain bid forms in duplicate, and on its exterior the name of bidder, address, name and location of project, classification of work, license number and classification of bidder, and acknowledgment of receipt of all addenda.

Bidders attention shall be called to all relevant sections of the North Dakota State Century Code regulating submittal of bids for Public Building Construction. All bidders must be licensed for the highest amount of their bids, as provided by Section 43-07-05. No bid will be read or considered which does not fully comply with the State Standards, and all deficient proposals will be resealed and returned to the bidder immediately.

All bids will be made on the basis of cash payment for such work. After bid opening the Owner will return the bid security of all except the three lowest responsible bidders. When the Contract is awarded, the remaining unsuccessful bidder's bond will be returned. The Owner reserves the right to reject any or all bids, and further reserves the right to award the Contract in the best interests of the Owner. The Owner reserves the right to hold the three low bids for a period of thirty (30) days after the date of the bid opening.

**Tribal Employment Rights Ordinance (TERO)** The successful bidder must comply with the provisions of the Tribe's TERO, including any licensing requirements. Bidders on this work will be required to comply with Executive Orders No. 11246, as amended, 11458, 11518, and 11625. The requirements for bidders and contractors under these orders are explained in the specifications. A minority preference of 5.25% has been approved by the Owner for Prime Bidding Contractors on this project. Contractors wishing to be considered for this preference shall include proof of their minority contractor status with the bid. Bidders on this work will be required to comply with the Clean Air Act (CCA) and the Environmental Protection Agency's (EPA) authority. As a result the bidders will be required to add an additional 1% fee to the total cost of their sales for the project. The project consists of various site improvements including sidewalks, fencing, benches, flagpoles, construction of four wooden pergolas, etc. for four visitor information sites, including the Cannonball Monument Site near Cannonball, ND; the Sitting Bull Burial Site and Standing Rock Monument Site in Fort Yates, ND; the Indian Memorial Site near Mobridge, SD.
