Minutes for November 5, 2009

Maintenance Full Time Status

Board discussed moving part time Public Works employee Pete Haas to a fulltime status. Since hiring Haas he has been working 20 hours during the winter months and 40 hours in Spring, Summer, and Fall. Mayor would like to keep it like this as he feels like there is not enough for two forty hour employees in the shop. Other board members feel like there are things that need to be done in the department such as meter replacements, shop inventory, and vehicle maintenance. Mayor stated that if the Full time superintendant feels like he needs extra help he is able to call Haas in anytime. This will be monitored on an ongoing basis.

Snow removal policy

Board discussed adding a snow removal policy for the next month's agenda.

Update on North McDougall and Dolan Drive

City Engineer, Brad Krogstad, was present to give an update on the paving plans resubmitted for North Lincoln 2nd – Phase 3 with regard to the curb grade changes on North McDougall Drive. The final plans signed by registered professional engineer, Dave Thompson with Toman Engineering, have been resubmitted and have been reviewed by the City Engineer. The City Engineer finds the plans to be an acceptable solution to the issue of the curb grades not matching between the Wheatland Hills

Development and North Lincoln 2nd -Phase 3. The revised design will provide steeper curb grades which will facilitate better drainage while minimizing the amount of fill that will be necessary to bring in on the Wheatland Hills side. The fill in on the Wheatland Hills side. quantity is approximately 50 cubic yards according to Mr. Thompson. With the council's approval, they feel that Toman Engineering has reached an acceptable solution for the curb grades and the connection. Krogstad would like the council's approval for him to sign the final plans as submitted while noting the potential implications that the Wheatland Hills developer will have to bring in some fill material and may require an engineer to revise the Wheatland Hills plan sheet. Once these plans are approved the plans will go to the engineer for Wheatland Hills as well. Also, Toman Engineering and Great Western will have to revise and update the previously submitted Three Party Agreement and Specifications to account for the construction taking place over a year later than expected. Toman Engineering and Great Western had previously stated that the construction of North McDougal Drive as laid out in the resubmitted paving plans will be done by the end of next . summer.

Thompson also stated that although he provided a possible curb grade profile for the Wheatland Hills side of North McDougall Drive, as the engineer for Great Western and North Lincoln 2nd-Phase 3 he and his firm are not responsible for anything other than the North Lincoln 2nd – Phase 3 Plans. --Ist motion –Unterseher—to have City Engineer sign the plans
