NOTICE OF PUBLIC HEARING ON THE ISSUANCE OF COLLEGE FACILITIES REVENUE BONDS UNDER THE MUNICIPAL INDUSTRIAL DEVELOPMENT ACT OF 1955 (STUDENT HOUSING LLC PROJECT)

NOTICE IS HEREBY GIVEN that the County Commission of Burleigh County, North Dakota (the "County"), will meet on September 3, 2014, beginning at 5:00 p.m. in the Tom Baker Meeting Room, City/County Office Building, 221 N. 5th Street, Bismarck, North Dakota, for the purpose of conducting a public hearing on a proposal that the City of Center, North Dakota issue revenue bonds in one or more series under the Municipal Industrial Development Act of 1955, Chapter 40-57, N.D.C.C., in order to finance the project described below. The project consists of the construction of two, 64-unit student apartment buildings together with functionally related facilities (the "Project"). The Project will be located on the campus of Bismarck State College, 1221 College Drive, Bismarck, North Dakota, and will be owned by Student Housing LLC, a North Dakota limited liability company whose sole member is Bismarck State College Foundation, a North Dakota nonprofit corporation. The amount of the proposed bond issue shall not exceed \$6,000,000. The proposed bonds will be limited obligations of the City of Center payable solely from the revenue pledged to the payment thereof, and may be secured by a mortgage or other encumbrances on the Project. No holder of any such bonds shall ever have the right to compel any exercise of the taxing power of the County to pay the bonds, or the interest thereon, nor to enforce payment against any property of the County. Student Housing LLC will engage in the business of developing student housing on the campus of Bismarck State College, and competitors are hereby notified that fact pursuant to Chapter 40-57, N.D.C.C. All persons interested may appear and be heard at the time and place set forth above or may submit their views in writing prior to the time of the hearing. 8/16 & 23 - 20740106
