The Bismarck School Board met on February 27, 2012, in the Tom Baker Room of the City/County Office Building. Board President King called the meeting to order at 5:15 p.m. and requested that the Business Manager call the roll.

Following agreement on the Agenda, Mr.

Uselman to give her reports. Mrs. Uselman shared information on student achievement data by reporting on the fall 2011 and winter 2012 MAP test results and on school building response to intervention processes.
Business Manager Ed Gerhardt presented

the financial report for January. Mr. Gerhardt reported that the General Fund balance was \$22,362,042 and that the total balance of all funds maintained by the Bismarck School District was \$31,853,513 balance of all funds maintained

as of January 31, 2012. Mrs. Uselman gave an update on the District Goals for 2011-12.

Fran Rodenburg, Assistant Superintendent of Elementary Schools and Student Services, gave an update on elementary enrollments for the current school year as well as projections for the 2012-13 school year.

Jennifer Anderson-Tuttle from the DLR Group reviewed the results of the community input meetings and gave a summary of their final recommendations which were Option 24 to 100. which were Option 2A and 2B as well as a modified version of Option 2A.
