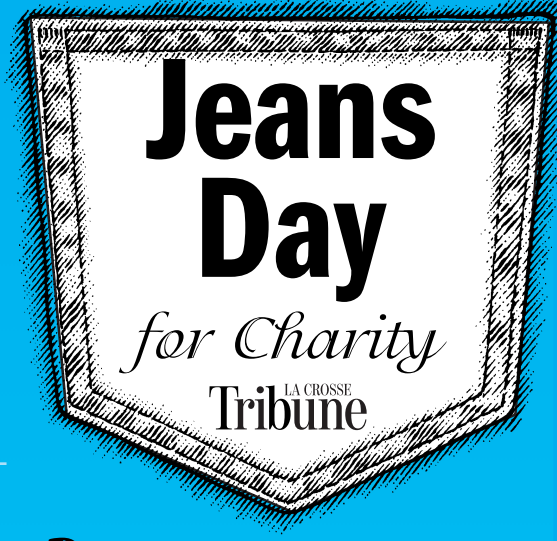


# Today is Jeans Day!!
