

What does this mean? THIS IS NOT AN EMER-GENCY. If it had been you would have been notified immediately. Total coliform bacteria are generally not harmful themselves. Coliforms are bacteria which are naturally present in the environment and are used as an indicator that other, potentially harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems. THE WATER IS SAFE TO DRINK, COLIFORM BAC-TERIA IS FOUND EVERY-WHERE, IT IS NOT DISEASE-CAUSING BACTERIA.
