This is to give notice that Franklin County has conducted an evaluation as required by (Executive Order 11988 for floodplain management), in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management, to determine the potential affect that its activity in the floodplain and/or wetland will have on the human environment for Community Development Block Grant under Title I of the Housing and Community Development Act of 1974 (PL 93-383). The proposed project(s) is located at Highway MM in Franklin County. Proposed project consists of con-structing a 6" water main along Highway MM from Beauty View Acres to Pine Lakes Subdivision. Proposed funding for the project is being provided by Missouri Department of Economic Development, CDBG program and the P.W.S. D. No. 3 of Franklin County. The proposed water main will cross the 100-year floodplain for approximately 7,000 linear feet. There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at greater or continued risk.
