STATE OF OKLAHOMA, COUNTY OF GARFIELD:

I, Michael J. Fields, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Garfield and in the State of Oklahoma, CHRISTOPHER JOSEPH REYNAUD did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

MURDER IN THE FIRST DEGREE ~ a FELONY, on or about the 25th day of June, 2016, by deliberately and intentionally taking the life of a human being when the Defendant did then and there unlawfully and with malice aforethought, cause the death of Daultn Dickerson by shooting Daultn Dickerson with a handgun, thereby inflicting certain mortal wounds in the body of Daultn Dickerson, from which mortal wounds Daultn Dickerson did languish and die.

This crime is punishable by death, imprisonment for Life, or imprisonment for Life without parole.

COUNT 2: ASSAULT AND BATTERY WITH DEADLY WEAPON ~ a FELONY, on or about the 25th day of June, 2016, by committing an assault & battery upon Alyssa Cull by shooting Alyssa Cull with a deadly weapon; to wit: a handgun.

This crime is punishable by imprisonment for up to Life.

ASSAULT AND BATTERY WITH DEADLY WEAPON ~ a FELONY, on or about the 25th day of COUNT 3: June, 2016, by committing an assault & battery upon Jonathan Winters by shooting Jonathan Winters with a deadly weapon; to wit: a 9mm handgun.

This crime is punishable by imprisonment for up to Life.
