- SHE HAS BEEN LIVING WITH AT THE RESIDENCE SINCE THAT TIME.
- SHE AND HAVE BEEN DATING ON-AND-OFF-AGAIN SINCE 2008.
- SHE AND
- THE ARGUMENT STARTED OVER ANOTHER FEMALE.
- THE FEMALE`S NAME IS (UNKNOWN LAST).
- SHE MET THE OTHER DAY AT THE DOG PARK.
- SHE CALLED ON THE PHONE.
- SHE WANTED TO INVITE OVER TO THE HOUSE WITH BOYFRIEND.
- DID NOT WANT BOYFRIEND TO COME TO THE HOUSE.
- THIS LED TO A LOUD VERBAL ARGUMENT BETWEEN THE TWO.
- SHE HAS HAD A COUPLE OF DRINKS TONIGHT TO INCLUDE A BUDWEISER STRAWBERRYRITA, AND TWO SHOTS OF PEPPERMINT SCHNAPPS.


- IS A MANIPULATOR.
- SHE SHOULD NOT HAVE HAD ANYTHING TO DRINK BECAUSE IT LEADS TO INCIDENTS LIKE THIS.
- SHE IS ALSO PRESCRIBED BUT SHE HAS NOT TAKEN ANY THE PAST TWO DAYS BECAUSE SHE RAN OUT.
- SHE HAS A PRESCRIPTION AT WALGREENS TO PICKUP MORE TOMORROW.
- THEN HANDED HER A PAIR OF SCISSORS.
- GRABBED BOTH OF HER ARMS BY HER WRIST AND STARTED TO SWING HER AROUND.
- *NOTE: I OBSERVED A SMALL MINOR ABRASION ON THE TOP OF TERESA`S LEFT WRIST APPROXIMATELY .25 INCH IN LENGTH AND A SECOND SMALL MINOR ABRASION ON THE TOP OF TERESA`S LEFT MIDDLE KNUCKLE APPROXIMATELY .25 INCH IN LENGTH.
- TOLD HER THAT HE'S GOT A GUN.
- NEVER DISPLAYED HIS GUN OR HAD HIS GUN IN HIS POSSESSION WHILE THEY WERE FIGHTING.
- THEN THREW HER OUTSIDE OF THE HOUSE ALONG WITH HER PURSE AND HER PHONE.
- TOLD HER TO LEAVE.

I THEN WENT BACK INTO THE NEIGHBOR'S RESIDENCE TO SPEAK WITH TERESA TO CLARIFY SOME STATEMENTS.

TERESA THEN ADVISED ME OF THE FOLLOWING:

- SHE IS
- SHE DID WANT TO HAVE COME OVER TO THE HOUSE TO HAVE A THREESOME.
- A THREESOME IS SOMETHING THAT SHE AND HAVE ALWAYS TALKED ABOUT DOING.
- THEY HAVE NEVER HAD A THREESOME BEFORE, THOUGH.
- DID NOT WANT TO HAVE A THREESOME BECAUSE HE WASN'T FEELING WELL.
- HANDED HER THE SCISSORS AS SHE STATED INITIALLY.
- SHE DID STAB IN THE ARM ONCE WITH THE SCISSORS.
- SHE NEVER STABBED AT ANYTIME ANYWHERE IN THE ABDOMEN.
- SLAPPED HER ONCE ON HER ARM.
- SHE THEN SLAPPED BACK
- SHE CANNOT RECALL WHICH ARM SLAPPED HER ON.
- *NOTE: I DID NOT OBSERVE ANY INJURIES TO TERESA`S LEFT OR RIGHT ARM AT THIS TIME.
- THREW HER OUT THE FRONT DOOR WITH HER PURSE AND HER PHONE.
- THEN LOCKED THE DOOR TO THE HOUSE.
- SHE HAD THE KEYS TO THE HOUSE.
- SHE THEN WALKED AROUND TO THE BACK, UNLOCKED THE DOOR, AND RE-ENTERED THE HOUSE.
- THIS IS WHEN GRABBED HER WRISTS AND STARTED TO SWING HER AROUND.

- TOLD HER TO GET OUT OF THE HOUSE AND GO BACK TO SAN DIEGO.
- THREW HER OUTSIDE AND LOCKED THE DOOR AGAIN.
- THIS IS WHEN SHE WENT OVER TO HER NEIGHBOR'S RESIDENCE.

UPON ARRIVAL TO THE JAIL, I ALSO TOOK MULTIPLE PICTURES OF TERESA'S INJURIES WITH MY AXON VIEWER AND UPLOADED THE PHOTOS TO EVIDENCE.COM.

A P.B.T. WAS ADMINISTERED AND TERESA SHOWED A BLOOD ALCOHOL CONCENTRATION OF 0.131.

TERESA WAS ULTIMATELY CHARGED WITH AGGRAVATED ASSAULT PER D.V. (ARS 13-1204.A2) AND DISORDERLY CONDUCT PER D.V. (ARS 13-2904.A6).
