On this day an Information was filed in the District Court in Cascade County, Montana, by the County Attorney. The Information charges the above-named Defendant with committing the offense(s) of:

COUNT I: DELIBERATE HOMICIDE, a Felony, in violation of M.C.A. § 45-5-102(1)(a).

YOU ARE THEREBY ORDERED to arrest and bring the above-named Defendant before this Court, or in case of my absence or inability to act, before the nearest or most accessible Judge in this County without unnecessary delay.

This warrant may be executed any time of the day or of night, INCLUDING DEFENDANT'S RESIDENCE/HOME AND PLACE OF EMPLOYMENT. ( )

DEFENDANT IS HEREBY ORDERED TO APPEAR BEFORE THE COURT NO LATER THAN 10:30 A.M. THE NEXT BUSINESS DAY AFTER ARREST IF RELEASED ON BOND.

Bail is fixed at: \$ 1,500,000.

CONDITIONS OF BAIL

Should the Defendant be released on bail, the following conditions should be adhered to:

- X 1. Obey all laws at all times;
- X 2. Contact his attorney at least once a week;

- 3. Maintain or actively seek employment;
- 4. Stay in school;
- 5. Do not possess or consume alcoholic beverages or illicit drugs, except as prescribed by a licensed physician;
- 6. Do not enter any establishment where alcohol is a chief item of sale;
- 7. Remain in the custody of \_\_\_\_\_, who agrees to supervise the defendant and report any violation of a release condition to the Court;
- 8. Do not leave the ~~State of Montana~~ Cascade County during the pendency of this action except with the written permission of the Court;
- 9. Do not associate with persons who use alcohol, illicit drugs or other intoxicants;
- 10. Do not associate with \_\_\_\_\_;
- 11. Attend all court hearings;
- 12. Avoid all contact with any alleged victim or potential prosecution witness in this case, including by phone, mail, or through a third person;
- 13. Observe a \_\_\_\_\_ curfew;
- 14. Reside at \_\_\_\_\_;
- 15. Do not operate a motor vehicle without a valid driver's license; and
- 16. Do not possess or be in control of any firearms, destructive devices or other dangerous weapons, including ammunition, black powder, or explosive devices, as defined by state or federal law.
- 17. Within 24 hours of release from custody, the Defendant shall be equipped with and begin active GPS (Global Positioning Satellite) monitoring by use of an ankle monitor or other device capable of determining his position by use of

GPS technology. The Defendant shall be solely responsible for paying any costs associated with GPS monitoring. Failure to begin monitoring within 24 hours or terminating monitoring without leave of the Court, including termination of services for failure to pay for monitoring, will result in a bail revocation.

\_\_\_ 18. Do not have contact with children under the age of 18, unless the child is related to the defendant by blood or marriage.

\_\_\_ 19. Abide by all rules and regulations of Adult Probation and Parole and report to Adult Probation and Parole as required;

\_\_\_ 20. Within 24 hours of release from custody, the Defendant shall be equipped with and began active alcohol monitoring by use of the SCRAM device, the Remote Alcohol Testing device, Soberlink device, or participation in the 24/7 Program at the Cascade County Sheriff's Office. The Defendant shall be solely responsible for paying any costs associated with alcohol monitoring. Failure to begin monitoring within 24 hours or terminating monitoring without leave of the Court, including termination of services for failure to pay for monitoring, will result in a bail revocation.
