Sarah,

I understand from my wife, Jennifer, that you are compiling a record of concerns expressed by the parents and players of the Capital High women's soccer team regarding first year head coach Nan Brisko. Jennifer and I would be happy to visit with you at your convenience to discuss the recently concluded season.

While I certainly had the opportunity to observe the team from the sidelines throughout the season and listen to the commentary of other parents as well as my own daughter, my primary interaction with Coach Brisko is reflected in the email correspondence below that I was asked to forward to you. This exchange was the result of friends and family congratulating Jaci on making All Conference Honorable Mention as reflected in numerous news stories throughout the state. The one exception to those stories was the article that appeared in the Helena Independent Record, that failed to list or the other three players from Capital that were mentioned in the other stories. As a result, I communicated with the IR reporter to point out that he neglected to mention the honors these young women received and you can see that exchange below where he clearly states that he was directed by the coach to omit those players' names. When I pressed him further, he was unable to provide any additional information.

It was at that time that I sought clarification from Coach Brisko. The response that I received back from her, which is below, is that (1) the list sent to the other media outlets was a mistake (how, why and who made this mistake I don't know but clearly she says it wasn't her), (2) that she didn't direct the reporter to not publish their names, and (3) that she was upset that I contacted the reporter instead of contacting her. To her credit, she did apologize for any hurt feelings this may have caused my daughter.

I, frankly, found her response lacking which is why I asked for the opportunity to meet with her personally.

Coach Brisko's response to our meeting request is also enlightening. While I am pleased that she is willing to meet and we do intend to meet with her, I was a bit surprised at how defensive she seems to be. I have never asked her for the criteria for all conference honorable mention, although I am now interested to know what the criteria is since I have no idea what it might be. I have also never asked that she change her criteria. In fact, I was surprised that was listed as having received post-season honors at all. But I was also surprised at the other all conference and all state selections from Capital High. So now I am interested in knowing what the criteria are for those honors as well. On this issue alone, I would hope that the criteria are uniform across the district so that the Helena High players are

treated similarly to the Capital High players. Frankly, it seems if we are talking about All Conference or All State honors, the criteria would be similar across the conference or across the state. How else would you adequately compare the players? But this is a bigger issue than what is before us right now.

Hopefully we will meet with Coach Brisko in the near future. I am hopeful that the other players/parents involved in this singular issue can participate. As for the other concerns expressed throughout the season by an overwhelming number of parents and players, we would be happy to visit with you about our perspective on that as well. Just let us know a convenient time for you. I will be out of town Sunday and Monday, and again on Wednesday and Thursday. As you can imagine, a number of players and parents are fearful of retribution and that their daughters will suffer in future seasons as a result of expressing their concerns. Jennifer and I have visited with about this possibility and she understands this could happen. However, she believes having these concerns raised now is the right thing to do regardless of how it impacts her future as Capital High women's soccer player. And, as parents, its important to us that we set an example for our daughter to do the right thing, which may not always be the most expedient thing.

Finally, you should be aware that in her original reply below, Coach Brisko does mention the school board getting involved with Jim Opitz on this matter. That is most likely a reference to my conversation with Aidan Myhre. I've copied Aidan on this email so she knows what has transpired since that time.

Dear Dr. Kultgen, Helena School Board Members, Mr. Opitz, and Mr. Zanto,

I am writing this letter in support of Nan Brisko as the head girls soccer coach at Capital High School. My daughter is a freshman, who played on the JV team this year. She had an outstanding experience under Coach Nan's supervision and leadership.

As a family, we have been involved in the CHS soccer program for the past 7 years. My oldest daughter played as a JV player, and my son played as a Froshmore, JV and Varsity player. As a parent, I have kept a close eye on the girls program through this time frame. In just one year, I feel that Nan has successfully created a positive culture within the program, and has placed an emphasis on improving the soccer skills, team work, physical fitness and decision making abilities of the student athletes. I watched as 17 players on this year's Varsity team all contributed and all were given meaningful playing time in every game, all season long. This is not usually the case in competitive high school sports, and has not been the case in the CHS soccer program in previous years. In this way, I feel the coaching staff, under Coach Nan's supervision, went above and beyond to create a meaningful experience for all student athletes in the program.

As a parent of high school athletes (my older kids participated in soccer, tennis and track) I have found many occasions that I did not agree with their various coaches. These situations have ranged from the positions my kids played, the strategy the coaches employed, the playing time they were afforded, the partners they played with, the events they participated in, etc. In the end, these all have to be the coach's decision. As parents, we may not agree from the sideline, but it is the ultimately the coach's responsibility to make the tough calls. I have found Coach Nan to be fair in making these decisions.

As a parent, I communicated with Nan regarding team dinners, t-shirt orders, the banquet and other items. I found that she had definite opinions about what she wanted for her teams, but was very approachable, willing to weigh the options, and then make a decision. She gave clear guidance concerning her expectations throughout the entire season.

The most poignant memories that I will carry with me from this year came during the final two games of the regular season in Kalispell. The Friday night game against Flathead, was an important game for the Varsity team as far as playoff seeding was concerned. The girls played their hearts out and won. As they made their way across the field to high-five their parents, they were met by a boisterous bunch of JV girls at midfield where hugs and cheers were exchanged. The next day, the JV girls had an outstanding showing against Glacier. It was one of those games were everything just came together at the end of the season. This time, it was the Varsity girls that stormed the field to congratulate their younger counterparts. In all the years I have been watching soccer, I have never seen the Varsity and JV teams with such close ties. To me, this is a strong indication of the kind of program Nan is building – a positive, inclusive program, with a very bright future.

This year in soccer was a positive experience for my daughter. She gained the skills and experiences that I would hope for as a parent of a high school athlete – team work, dedication, leadership, physical activity and comradery. Coach Nan expected a lot from all of the girls in the program, and I feel as if they rose to the occasion. She is a tough coach and when she demanded more from them, they found it within themselves to do more. I find Coach Nan to be of the highest character and integrity, and I hope that she will continue to serve as the head coach for many years to come.

Retreat: Attached to this email is the information Ginny provided that summarized our last meeting and provided "homework" for the upcoming meeting. I sent this to you a while back, but thought worthwhile to send again.

Non-Tenured Meetings: This week has been very hectic as Greg, Bill Rasor and I have been meeting individually with each principal about their non-tenured teachers. As you know these meetings happen twice per year as we discuss our new teachers. There are approximately 125 non-tenures, which means those teachers who have been with us less than four years.

We have not done this in recent memory and our current provider Montana Schools Group Insurance Authority (MSGIA) has provided our coverage. A third party was hired to conduct the RFP and all bids were received. We received one bid from Montana State Fund and MSGIA did not provide a bid. The bid we received provided substantial savings, however we want to make sure the bid provides all the services we are accustomed to. We are in a quandary why MSGIA did not bid and I have talked to their director Shawn Bubb. This past week I started working with Terry Cosgrove (local lawyer) on getting his opinion on the RFP. I am meeting with him

on Monday to get his thoughts.

Good Morning Libby,

First and foremost, congratulations on your re-election to the Board of Trustees. Betsy Baur kindly provided me with your email address after I expressed concerns pertaining to the outcome of the board meeting on April 27, 2016. My main concerns are in regards to the moral and ethical implications of processes that led to the opening of the Capital High School Girls Soccer Head Coach position, the precedent this decision established for district employees, and the message that this outcome sends to our student athletes.

Given that the majority of complaints were brought to the attention of the district (not the coaching staff) during the post-season, the coaching staff was not given the opportunity to address and mitigate many of these concerns during the season, or otherwise. As a result of the board's decision, the coaching staff will not be afforded the opportunity to partake in addressing many of these concerns. The message this sends to our student athletes about how to handle adversity and proper conflict resolution is extremely concerning.

Secondly, the board has the responsibility to be impartial, fair and professional and in this situation, certain trustees failed in this regard. Numerous individuals directly involved with the Capital High

School soccer program and concerned members of the public with no direct involvement have contacted me regarding the perceived "conflict of interest" (policy 1027, see attached) between specific members of the board and parents that filed the formal complaint and ultimately supported the motion to open the CHS Girls Soccer Head Coach position. Many people feel these board members should have recused themselves from voting due to the personal relationships that exist between these parties. I understand that Helena is a small community and as such, the potential for "conflicts of interest" increases. That being said, the ramifications of a perceived "conflict of interest" due to 1) the controversial nature of this situation, 2) the manner in which the events of the meeting unfolded and ultimately, were orchestrated, and 3) the subsequent decision by the board to open the position, should be of significant concern regardless of community size. To better illustrate this point, my husband, myself and a number of others were witness to Chair Myhre having a lengthy private conversation with lead vocal parent Mark Baker immediately preceding the board meeting. The perception of this interaction prior to a highly controversial board meeting was definitely not favorable to the professionalism and impartiality of the board. Moreover, the conversing between Chair Myhre and Trustee Lovshin during the 2-minute period the board took to reflect upon the information prior to voting, further demonstrates the lack of professionalism by certain trustees, especially given their subsequent votes in support of the motion and given that the school district attorney had to quickly approach Chair Myhre and Trustee Lovshin and inform them this action was not allowed. Attached you will find documentation that highlights these relationships and supports the notion that policy 1027 was violated.

The precedent this decision sets district wide should have all Helena School District employees concerned about the protections the district can provide regarding employment. The apparent disregard exhibited for 1) the findings of the investigation absolving Coach Brisko and asserting that the accusations were unsubstantiated, and 2) the district administration recommendations to renew Coach Brisko's contract, supports the conjecture that politics played a significant role in the board's decision. Board members openly acknowledged that this situation was a failure of the entire system, and I am in complete agreement with the aforementioned conclusion. However, this statement begs the question, "Why was Coach Brisko forced to be the martyr?". In lieu of providing guidance and mentorship to district coaching staff, the resolution was to effectively "fire" Coach Brisko by opening up the position. Not only does this action send a powerful message to district employees, parents and student athletes, but this type of resolution is a slippery slope. The board's decision publicly communicates their lack of faith in the Helena School District Administration, is a vote of no confidence with regards to opens a pathway for all parents who have issues with a coach to bypass the district and approach the board to obtain the resolution they desire, and signifies that money, power and connections hold more weight than factual information. Moreover, the Capital High School girls soccer program just lost three very experienced female coaches as a result of the board's actions. The Helena community may be small, but Helena soccer coaching community is infinitesimal.

With regards to the varsity players that supported the motion to open the position, only three of these players have any future investment in this program. Four returning varsity players opposed the motion and the remaining varsity players were not present (some of which were out of state on a school trip and therefore had no opportunity to show their support). Another concern stems from the fact that the JV players were not represented by either the investigation or at the board meeting. They were

effectively removed from this process, yet they are the future of the program and now find themselves without a coaching staff through no fault of their own. The impacts extend even further to the incoming 8th graders who have expressed concerns to me personally about the future of the program given the board's decision. These concerns are significant in nature, as some of these individuals are considering transferring to Helena High School for the sole purpose of their soccer program. The lack of foresight by the board members that supported the motion is evidenced by the far-reaching impacts that have resulted from this decision.

My purpose for reaching out to you today is three-fold: 1) to request that two trustees call a special meeting to reconsider the motion to open the Capital High School Girls Soccer Head Coach position under policy 1065 (see attached), 2) to incite policy change to ensure the integrity of the democratic processes that govern the board, and 3) to advocate for the implementation of better conflict resolution practices at the administration level. Thank you for your time and consideration, and I truly look forward to the opportunity to speak with you further about my concerns.

The position the Board recently found itself in with the CHS Soccer Coach was unfortunate. Based on the information provided in the investigation, the Board can feel confident that it made the right decision. The coach in question was clearly a poor fit for this team and, given the climate of negativity that she helped create, we can surmise that she would have had great difficulty growing this program to its full potential.

As we continue to work as a Board toward developing community trust and staff empowerment and in light of the fact that statements were made during the special board meeting on April 27th that we would not be doing "business as usual" I would like to recommend the following action to address this issue and assuage the feelings of agitation and apprehension that are surely transmitting through the coaching staff.

I recommend that a carefully crafted letter be sent to all varsity and junior varsity coaching staff which acknowledges the regrettable way in which this situation was handled and recognizes that one positive outcome was that it revealed many gaps in our current coaching policies and procedures. The letter would invite those who are interested to participate in a committee that will review our current policies and make recommendation for change.

I believe this type of of targeted outreach will go a long way in repairing bad feelings and legitimate apprehensions about accepting coaching positions as well as bring needed change to our policies in this department.

I feel strongly that the Board needs to act swiftly and proactively to ensure that we do not find ourselves in the this predicament again. It only serves to generate ill will between the Board the community and the coaches and, most importantly, creates difficulty for our student athletes who deserve so much better.

I would like to have a discussion regarding this issue and would love to hear other ideas as well.
