16 first duly sworn according to law, complains and says:


17 That the above-named defendant is accused by this  
18 Complaint of the offense of CRIMINAL DISTRIBUTION OF DANGEROUS

AFFIDAVIT

21 MATT LEWIS, being first duly sworn deposes and says:

22 That he is an Officer with the Helena Police Department/Missouri River Drug Task Force  
23 and in such capacity states the following in support of filing a complaint/warrant of arrest  
24 charging the above-named defendant with the felony offense of CRIMINAL DISTRIBUTION OF  
25 DANGEROUS DRUGS (methamphetamine), as defined in Sections 45-9-101(1) and 50-32-  
26 224(3), MCA, alleged to have occurred on or about August 13, 2015, in the County of Lewis and  
27 Clark, State of Montana, based upon the reports of the Helena Police Department/Missouri River  
28 Drug Task Force, summarized, as follows:

1 On August 13, 2015, a Confidential Informant (CI) for the Missouri River Drug Task Force  
2 advised they could purchase one gram of methamphetamine (meth) from Kahner Leary. CI's  
3 person and vehicle were searched with nothing illegal located. CI was provided with \$120 of  
4 MRDTF funds and an electronic recording/transmitting device (wire) before responding to the  
5 meeting location.  
6

7 The CI met with Leary who made arrangements by phone to meet another party at the  
8 apartment complex. A few minutes later the CI sent me a text advising the methamphetamine was  
9 coming from Jimmy Joe Flanagan. Detective McDuffie observed Flanagan arriving and driving  
10 out of the parking lot after meeting with the CI and Leary.  
11

12 CI's person and vehicle were searched again and nothing illegal was located. CI provided me  
13 with one small clear plastic baggie containing approximately one (1) gram of a white crystalline  
14 substance. CI advised Kahner had contacted Flanagan and arranged to collect the  
15 methamphetamine from him to complete the transaction with the CI.  
16

17 The evidence purchased was processed at the Law Enforcement Center and tested presumptive  
18 positive for methamphetamine on a NARTEC Test kit. The bag and its contents weighed  
19 approximately one (1) gram total on a beam scale in the evidence room.  
20

21 Further Affiant sayeth naught.
