25 years for murder

KONRAD CASEBEER MURDER TRIAL

Sherri Alvarado acknowledged the family of Konrad Casebeer also will deal with loss now that Casebeer will be in prison for murdering her son, Antelmo "Temo" Herrera-Jimenez.

Unlike her son, she said, Casebeer is still alive for his family to visit.

"You have your son," Alvarado said in a statement before Casebeer was sentenced to 25 years in prison Thursday afternoon. "You can still call him. You can still hear him. You can still smell him."

Klamath County Circuit Court Judge Rodger Isaacson handed down the state-mandated minimum sentence, which Casebeer will serve concurrently with a five-year sentence on related convictions of unlawful use and possession of a weapon. Casebeer is not eligible for early release under Measure 11 guidelines.

Crash victim moved to Bend

Four people remain hospitalized after Wednesday crashes

Four people remain hospitalized after sustaining injuries in one of four traffic crashes that blocked Highway 97 north of Klamath Falls intermittently for more than five hours Wednesday afternoon.

Reba Phillips, 81, of Livermore, Calif., sustained head injuries in the collision and was transferred from Sky Lakes Medical Center to St. Charles Medical Center in Bend, where she is listed in serious condition, said Kayley Mendenhall, St. Charles communications coordinator.

Three people remain hospitalized in Klamath Falls. Margaret Hughes, 69, of Porterville, Calif., is listed in critical condition, and Marvin Hughes, 67, also of Porterville, and Barbara Emmett, 79, of San Jose, Calif., are listed in fair condition, said Sky Lakes spokesman Tom Hottman.

Defense attorney Shaun McCrea of Eugene argued for a lesser sentence because of Casebeer's age, his lack of prior criminal violence and other factors.

Isaacson dismissed those arguments, and said he was struck by one fact in the case: Casebeer held on to the shotgun shell from the shot that killed Herrera-Jimenez even though he disposed of the weapon.

"It seemed to be you were keeping it as some form of trophy," the judge said.

Herrera-Jimenez's three sisters and one of his brothers, along with Alvarado, made statements to the court before Casebeer's sentence was announced. They asked Casebeer why he killed their relative and whether he felt remorse. One sister, Angie Jimenez, brought her two young children to stand before Casebeer.

"Look, you guys, this is the man who killed your uncle," she said, sobbing.


ABOUT THE CASE

Antelmo "Temo" Herrera-Jimenez, 18, was found dead from a shotgun wound to his chest in a garden near Klamath Union High School in late August 2009.

Witnesses told authorities Konrad Casebeer, then 18, shot Herrera-Jimenez, and authorities said the incident began as a prearranged fight. Casebeer and codefendant Kyle Mahan were arrested on the grounds of the California state capitol in Sacramento in the days after the shooting, when a law enforcement officer smelled marijuana.

Series of crashes

Minutes before noon Wednesday, a pick-up truck and two passenger cars collided on Highway 97 near Hagelstein Park, injuring all six people involved. As traffic backed up behind the accident, a Klamath County Sheriff's deputy responding to the crash collided with another pick-up truck. Oregon State Police are still investigating that collision, said OSP Trooper William Ellena.

Later in the afternoon, about two miles south of the first crash, a semi-truck driver tried to turn around to avoid backedup traffic, but jackknifed and became stuck. After that, two passenger vehicles collided near the intersection of Highway 97 and Algoma Road. At 3:45 p.m., a passenger car rear-ended a semi-truck stuck in the traffic, Ellena said.

Traffic was blocked almost continuously on the two-lane highway from noon until about 5:30 p.m. Wednesday.
