### CRIMINAL COMPLAINT

**The below-named complaining witness being first duly sworn states the following:**

#### **Count 1: CRIMINAL DAMAGE TO PROPERTY**

The above-named defendant on or about Saturday, May 06, 2017, in the City of Madison, Dane County, Wisconsin, did intentionally cause damage to the physical property of another, two windows, belonging to The State of Wisconsin, without that person's consent, contrary to sec. 943.01(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

#### **Count 2: ENTRY INTO A LOCKED BUILDING**

The above-named defendant on or about Saturday, May 06, 2017, in the City of Madison, Dane County, Wisconsin, did enter the locked and enclosed building of State of Wisconsin Capitol Building, without the consent of the victim or person in lawful possession of the place, contrary to sec. 943.15(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

#### **FACTS:**

Your complainant is a Court Officer with the Wisconsin State Capitol Police Department and for this complaint is relying on the written police report(s) submitted by Wisconsin State Capitol Police Detective Chris Litzkow.

Det. Litzkow reports on May 6, 2017, at approximately 9:45 a.m., Capitol Police Officers arrived at the Capitol building, 2 E Main Street, in the City of Madison, Dane County,

Wisconsin, to begin the process of opening the building for the public for daily business. Upon arrival, officers discovered a dark red substance believed to be blood located in several areas throughout the building. One broken window was located inside of the first-floor men's bathroom in the west wing, door 100W. Also located inside that bathroom was a grey t-shirt and two black dress-style men's socks. Each of those three items had a dried dark colored substance on them believed to be blood. The second broken window was located on the fifth floor of the Capitol in the SW wing. A majority of glass was located outside of the building on the sill and landing below. There was a dark red substance believed to be blood in the landing area inside the building near the window.

On May 7, 2017, at approximately 1 PM, Det. Litzkow received a telephone call from Sgt. Price. Sgt. Price explained to Det. Litzkow that a suspect had been developed from surveillance videos and other investigative work. Videos showed a white male subject, getting into a white sedan. City of Madison Police Department had a pursuit with a similar white vehicle and was able to provide a license plate number from the car, which had a registered owner with an address in the Town of Turtle (Rock County), Wisconsin. Vehicle registration tag was WI Auto ending in ZLD and a DOT records check indicated it was a white 2014 Chevy Impala, and a registered owner of Zachary D. Bigelow, the defendant.

At approximately 4:00 p.m., officers arrived at Zachary D. Bigelow's (referred to defendant hereinafter) residence. The defendant was outside and Det. Litzkow directed him to their squad car to speak with him. Det. Litzkow saw that the defendant had cuts to both of his hands, and scrapes on his forearms. The defendant explained that he had been at a casino in Madison Friday night into early Saturday morning. Following the casino, the defendant said he drove downtown in Madison to get some more drinks. The defendant explained that he had been exploring, and entered the Capitol. The defendant admitted to breaking the windows and scaling the building. The defendant stated several times that he was still filling in the missing pieces of what happened.

Your complainant believes the statements of the Defendant(s) to be truthful and reliable insofar as they are admissions against penal interest.
