Purpose of DOL Grants

- Projects benefiting States and communities
- Projects which help people find, get and keep jobs
- Projects which lead to workforce development in the Region

Two Kinds of Grants

Formula awards:

Funds are awarded by statute (usually to States) for Congressional purposes

Discretionary awards:

Funds are awarded on a competitive basis to eligible applicants to operate a variety of workforce programs related to specific target groups or demonstration/pilot programs, including demonstration projects in high growth jobs, prisoner re-entry and youth offender programs, disability programs, and national emergency grants. ETA also administers the grant approval and oversight process for Congressional awards ("earmarks") to specific organizations.

Veterans Priority of Service

 The Assistant Secretary of Labor for Veterans' Employment and Training shall promote and monitor participation of qualified veterans and eligible persons in employment and training opportunities under title 1 of the Workforce Investment Act of 1998 and other federally funded employment and training programs

- * a veteran shall be given priority over a nonveteran for receipt of employment, training and placement services in job training programs if the veteran meets the program's eligibility requirements.

SGA = Solicitation for Grant Applications

 Published in Federal Register and Grants.gov

The 7 SGA Steps

- · Grant idea is authorized (Congress and DOL)
- Application & eligibility requirements developed
- SGA is published
- Applications received
- Review and rating phase
- Awards announced
- Grant Operations begin

An Example of Rating Categories
