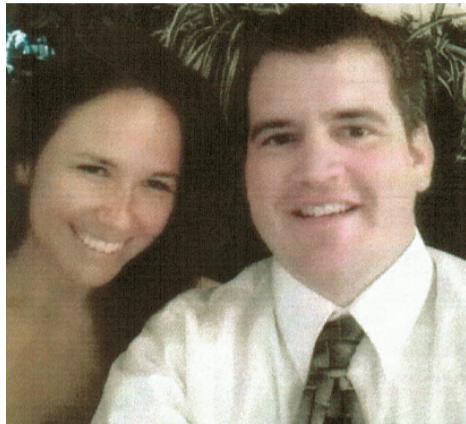


**Crista Marie Fopeano and Bradley Robert Bernardino**
