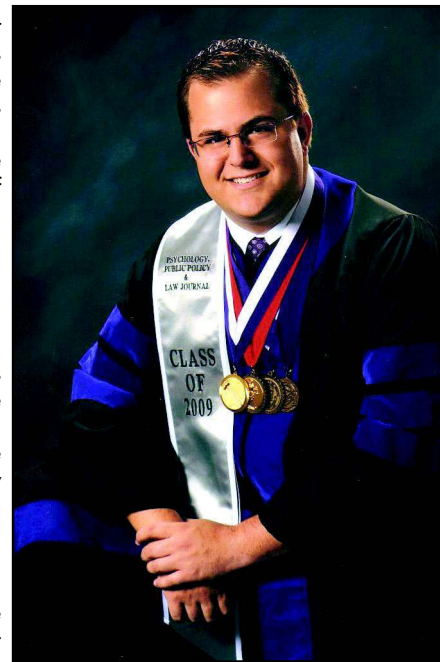
Kyle has accepted the position of law clerk for the Honorable Judge Michael Vigil who serves on the New Mexico Court of Appeals.

Christopher Louis Pizzo was awarded the degree of Juris Doctor with Honors by the University of Miami School of Law in Coral Gables, Florida on Sunday, May 17, 2009. Christopher, who received his undergraduate degree in Political Science and History from Boston College in 2006, was selected to serve as a Marshall of the Commencement Exercises in



recognition of his outstanding academic and extracurricular achievements. While in law school, he was elected President of the Moot Court Board, which under his leadership rose to the rank of 6th in the United States. Christopher also participated in the National Appellate Advocacy Competition for two consecutive years. Considered the nation's most challenging law school invitational tournament, Christopher received the Best Oral Advocate Award in 2009 after reaching the final round in 2008. Christopher was also recognized as the first winner of the Humberto J. Peña Award for Oral Advocacy, following his 1st Place finish in the John T. Gaubatz 1L Moot Court Competition in 2007.

In addition, Christopher served as a Senior Editor of the Law Journal, and as the first-ever student Chairman of the M. Minnette Massey Award Committee, which selects a distinguished alumnus for recognition based on superior contributions to the School of Law. During his second year, he was also selected by the faculty for a prestigious Dean's Fellowship, through which he developed and taught a weekly seminar for over 80 first year students in Constitutional Law. Upon graduation, Christopher was among a small group of students at the University of Miami inducted into the nationally renowned Order of the Barristers honor society, and was invited by the University administration to serve on the Board of Directors of the Law Alumni Association.

Christopher is the son of Louis and Angie Pizzo of Parkland, Florida. He is the grandson of the late Louis and Josephine Pizzo of Rosenhayn as well as Mrs. Violet Coia and the late Gino Coia, Sr. of Vineland.
