This chart shows differences in average property tax bills from 2009 to 2010 or area municpalities. The last column shows the percent change in the net property tax bill when the average 2009 property tax Saver rebate for each town was deducted from the average 2009 tax bill.No rebate checks were provided in 2010. Qualifying homeowners will receive a credit for last year on their property tax bills in May. However, the credit will be for only one-quarter of the amount the property owner would normally receive.
