Borrowing \$5,000 from his two librarian sisters, he moved from Ohio to Davenport and opened his distribution company.

During the early years, the company installed more than 12,500 Delco generators across the Midwest. The Delco Light Plants were a 32-volt system for rural electrification. In fact, one of the original generators is on display at Republic – alongside a Frigidaire, with sign that says the generator had been installed on a farm near Manlius, Ill., in November 1916.

Back then, "there was electricity in the larger communities but no power out in rural America," Kilmer said.

Republic's business flourished from the sale of Delco Light Plants until the creation of Rural Electrification Act in the 1930s made the light generators obsolete. Republic shifted focus to and selling and pioneering mechanical refrigeration and air conditioning in the in the late 1960s. Midwest. It became a distributor for Frigidaires, and other small kitchen appliances such as the iron and mixer.

With its proximity to the Mississippi River, Republic found a market in equipping steamboats with commercial refrigeration, and then introduced mechanical refrigeration for the home. In the 1950s, with the advent of window air conditioning and later central air, the company became the largest distributor of residential heat ing and cooling equipment in the region, Kilmer said.

The company moved to its present-day location in the mid 1940s. Kimmel Jr. died in 2002. Its main headquarters is the former Gordon Van Tine warehouse


