THE STATE OF TEXAS, TO ANY PEACE OFFICER OF THE STATE OF TEXAS:

You are hereby commanded to arrest AROCHI, ENRIQUE GUITIERREZ, Defendant, W/M, 5'09", 175 LBS., BLACK/BROWN, DOB: 03/12/1990, TEXAS I.D. #37749265, and immediately bring him before the court to be dealt with according to law. Said Defendant has been accused of the FELONY offense:

SEXUAL ASSAULT CHILD, P.C. 22.011, F/2

which is against the laws of the State of Texas (and against the city ordinances of said city.)

CONDITIONS OF BOND (XXX) the person described above shall not have direct or indirect contact with the victim in person, by phone, by third party, or by any means. He is not to be within five hundred feet of the victim or victim's residence at any time as a condition of bond in this offense.

BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant, Investigator P.D. Jackson #4146, who after being duly sworn on oath deposes and says that he/she has good reason to believe, and does believe, that heretofore, to-wit on or about or between October 22, 2012 and February 22, 2013, and anterior to making and filing this complaint, Sexual Assault Child, P.C. 22.011, F/2, in the County of Collin and State of Texas

AROCHI, ENRIQUE GUITIERREZ W/M 03/12/1990

Then and there intentionally or knowingly cause the penetration of the female sexual organ of SMITH, JENNIFER [a pseudonym] W/F [REDACTED], a child who was then and there younger than 17 years of age and not the spouse of the defendant, by male sexual organ. This offense occurred at 1218 Harvard Ln, Allen, Collin County, Texas.

1. On January 28, 2015, Plano Police Department Detective C. Stamm turned over Plano P.D. #2015-13598 Information Report alleging sexual assault child offense had been committed at 1218 Harvard Lane, Allen, Texas. Detective Stamm provided Affiant with recorded interviews she had had with the alleged victim, who is using pseudonym Jennifer Smith.
2. Affiant watched/listened to said recordings and learned that Jennifer Smith worked at [REDACTED], Texas and met the alleged suspect Arochi, Enrique Guitierrez W/M 03/12/1990, who worked there as a server. Approximately a month later, Arochi began dating Jennifer, who was 16 years of age at the time. Arochi was 22 years of age although he had initially told Jennifer he was 19 years of age. Jennifer told Detective Stamm that during the relationship, which lasted approximately 6 months, she would on occasions spend the night at Arochi's resident located at 1218 Harvard Lane, Allen, Texas where his parents live. Jennifer said Arochi had told his parents that Jennifer was 17 years of age; and on her actual 17th birthday Arochi's parents had gotten her a birthday cake with 18th birthday on it. Jennifer reported that Arochi had had vaginal sexual intercourse with her approximately 15 to 20 times at this residence in his bedroom. Jennifer also reported that Arochi would perform oral sex on her and he would have her perform oral sex on him. Jennifer reported the sexual contact began when she was 16 years of age and continued after she turned 17 years of age.
3. Detective Stamm had also provided Extraction Report from Arochi's cellular telephone examination conducted by Plano Police Department.

Affiant saw an Instant Message on November 30, 2014 at time stamp 9:10:40 from 214-966-8748 (Arochi) to [REDACTED] (Rand) stating, "I'm glad I fucked [victim's name]."

4. On February 10, 2015, Affiant interviewed Jennifer's mother, [REDACTED] [same last name as victim], at the Allen Police Department. [REDACTED] told Affiant that Arochi and Jennifer dated for approximately 6 months after they had met at [REDACTED]. [REDACTED] said that prior to Christmas of 2012 when Jennifer was still 16 years of age she had found out from Jennifer that she had spent the night at Arochi's residence in Allen, Texas.
5. On February 16, 2015, Affiant received employee records from [REDACTED] and it showed Arochi began working there on September 13, 2012 and Jennifer began working there on October 22, 2012.
6. On February 17, 2015, Affiant interviewed [REDACTED] who is Jennifer's friend and former co-worker of Jennifer and Arochi at [REDACTED]. [REDACTED] told Affiant that Arochi and Jennifer dated shortly after Jennifer began working there and that Jennifer had told her they had had sex.

Affiant is a certified Peace Officer employed by the City of Allen Police Department and currently assigned to the Collin County Child Abuse Task Force. Affiant believes all facts contained in this affidavit are true and correct to the best of her knowledge.
