# **DuBois man** arrested on drug charges

DuBOIS – Drug charges have been filed against a DuBois man according to Clearfield County District Attor-

ney, William A. Shaw Jr.

Shaw identified the man as Robert Allen Selfridge, 34, N. Street. Church DuBois.

Sergeant Kris Kruzelak of the SELFRIDGE Sandy Township Police Department filed a criminal complaint Monday charging Selfridge with two counts of possession with the intent to deliver a controlled substance, persons not to possess, use, manufacture, control, sell or transfer firearms, firearms not to be carried without a license, four counts of possession of a controlled substance, possession of a small amount of marijuana and possession of drug paraphernalia.

An affidavit of probable cause filed with the complaint states that on Feb. 19, the Sandy Township Police Department responded to the Homewood Suites hotel located on Industrial Drive, Du-Bois. for an activated fire alarm. Officers were informed that the building's fire alarm had been activated and smoke was detected in room 235. Officers were also told that when hotel staff entered the room, they smelled burnt marijuana and several

of the occupants fled the room, however one man remained in the room.

The man was observed to be placing unknown items in two duffel bags, and left the room and placed the bags into a car. He then returned to the hotel and paid for the room for an additional night, and walked down the hall and entered the restroom the same time that officers arrived on scene.

Officers made contact with the man, identified as Robert Allen Selfridge, and he was taken into custody. Hotel employees directed officers to the vehicle that Selfridge had placed the bags in, and observed a knitted bag that was filled with several plastic bags. Officers also smelled marijuana. They obtained and executed a search warrant for the vehicle and located three handguns, methamphetamine, marijuana, cocaine, buprenorphine hydrochloride, prescription pills, various items of drug paraphernalia, a large amount of U.S. currency, and a wallet containing Selfridge's Pennsylvania Photo Identification.

Shaw said Selfridge was arraigned by Magisterial District Judge James L. Hawkins on Feb. 20, and Hawkins established

DuBOIS — The many closings and delays due to snow and below-freezing temperatures means а change in the DuBois Area School District's calendar. Superintendent J. Mark Heckman said Wednesday.

Wednesday, March 4, which was originally scheduled as a flex day, will now be removed and students will have a full day of instruction, Heckman said.

"This week, we have a half day of in-service with conferences plus a full day parent conferences, for Heckman said. "I don't want to go back in another week and have another flex day with all the snow days we've had. When we do the revised calendar after all the snow days are done in April, the revised calendar would reflect that. I just feel that's the right thing to do. So March 4 will be a full day instead of a flex day."

Currently, the last student day would be June 5, Heckman said.

"But, obviously, it's not set until we stop having snow," Heckman said.

So far, the district has had 10 two-hour delays, five cancellations and one early dismissal for a total of 16 weather-related missed school days, Heckman said after the meeting.

"Are we looking at any virtual school days?" Director Bev Kurts said. "I see a lot of schools doing it and they don't have to take a day off.'

Heckman said the administrative team has discussed virtual school days. He explained that the state has approved for school districts to create a virtual plan that if they have snow days, students could go online and take classes online and it counts as a day.

## Role of new Regional Rail Authority remains unclear

RIDGWAY — As the path to reconstruct a 20-mile abandoned rail corridor in Clearfield County continues to be forged, many questions remain unanswered on what the public-private partnership will look like.

In one of the first established steps to get the project off the

ground, three of the six counties in North Central Regional Planning & Development Commission's coverage region - Clearfield, Jefferson and Elk counties - have approved nonbinding resolutions to explore organizing a Regional Rail Authority.

The exact role of the authority in relation to the proposed publicprivate partnership between North Central, RJ Corman Railroad Co. and Genessee & Wyoming to reconstruct a the rail corridor between DuBois and Curwensville remains unclear.

"This is a really big deal and it has the potential to be even bigger than what we originally perceived it to be," North Central's Executive Director Eric Bridges said, adding the railroad has become a "front burner issue" for the agency.

Executive committee member Bob Esch of American Refining Company said it's important for people to come to the table in this project who truly understand the rail industry.

'There has to be a real discussion about what the rail systems look like," Esch said.

McKean County Commission and board member Joe Demott asked a question weighing on the minds of several of the board's members, "What is going to be the focus of the
