# No tax increase in Sandy Twp. budget

DuBOIS — Monday, the Sandy Township Supervisors gave final approval for the \$8,912,938 2015 budget, which includes no property tax increase.

The real estate levy of 15 mills includes 12 mills for general government, 2.5 mills for fire protection and onehalf for the DuBois Public Library.

It means the owner of a \$50,000 property will pay about \$187 in taxes to the township. Residents also pay property and other taxes to Clearfield County and the DuBois Area School

The general fund budget lists revenues of \$3,993,900, an increase of \$196,165 from last year's budget, and expenses of \$3,942,650, an increase of \$145,650 from last year's budget.

The budget also includes \$54,868 for the Mountain Run Turn Back project and \$500,130 for the Mountain Run Bridge project.

The liquid fuels fund, which is separate from the general fund and is financed by the state with fuel taxes, totals \$1,811,440. Last year's allocation was \$1,126,750.

The municipal authority budget, which is financed by user fees, lists revenues and expenses of \$2,552,600, was also approved by the supervisors at the municipal authority meeting Monday. Sewer totals are \$1,794,500 and water totals are \$758,000.

The supervisors tabled an order on a house demolition located at 1865 Basse Terre Road, Treasure Lake. A public hearing was held Nov. 17 and Bill Kulbacki of Pennsafe Building Inspection Services LLC said the house is dangerous and dilapidated and in need of some kind of abatement, repair

## Supervisors updated on permit for injection disposal well in Brady Twp.

DuBOIS - Duane Marshall of Highland Street Extension thanked the Sandy Township Supervisors for its letter to the EPA's Environmental Hearing Board opposing a permit for a deep injection disposal well in Brady Township. The well would dispose of liquids used in the hydrofracturing of the Marcellus Shale laver.

Marshall said about 120 petitions in opposition were submitted and the deadline for the board to respond has been extended until Jan. 23.

Marshall also told the supervisors that another injection well is

"Not really because they would need a deed," Kruk said. "The deed would have to be signed by the property owner. We have an address for her but no contact has really been received from her. # Fox Twp. couple arrested on drug charges

KERSEY — More than 138 grams of bath salts, a powerful and highly addictive synthetic drug, as well as \$3,000 cash were seized from a Fox Township home when the Office of the Attorney General's North Central Municipal Drug Task Force served a search warrant Dec. 9.

For the past several months, the Office of the Attorney General's North Central Municipal Drug Task Force has had an ongoing investigation into narcotics sale at the residence of Cynthia Marie Bizzak, 49, and Michael Todd Bizzak, 44, both of 491 Main St., Kersey.

St. Marys police and task force members served a search warrant at the couple's residence Dec. 9 after Elk County probation officers reported finding bath salts and drug paraphernalia during a home visit. At that time, probation officers took the Bizzaks into custody and transferred to Elk County Prison for violating probation.

In addition to cash and drugs, the task force also found drug paraphernalia, packing materials, and electronic devices alleged to have been used to order bath

Records were also recovered from the house showing money transfers to China, where the majority of the drug is produced and shipped from, as well as "owe sheets" which show the weight and cash amounts of controlled substances sold since 2013.

This bust comes on the heels of a string of summer raids in which more than 1,000 grams of bath

# St. Marys Council discusses drilling zoning proposal

ST. MARYS — For nearly two weeks, an ominous red glow has hung over certain parts of St. Marys as a reminder of the impending Marcellus Shale boom.

According to other media reports, Seneca Resources began the flaring of its wells Dec. 3, adding it typically lasts 10 to 15 days or until the flow of liquid and gas, as well as its pressure, are stabilized.

With the current flaring taking place and its potential for carcinogen release into the atmosphere, Brock urged the council at Monday's council meeting to hold firm to its current drilling zoning proposal which plac-

es a well 2,000 feet from a dwelling.

Seneca Resources, which owns 56 percent of the mineral rights in Elk County, has a different perspective of the ordinance.

In October, an attorney representing Seneca Resources threatened the council with a potential lawsuit if it passes a zoning ordinance requiring oil and gas developers to set well pad perimeters 2,000 feet away from a dwelling. The council has been discussing and researching the ordinance since March and seemed unshaken by the threat.
