Ex-firefighters waive arson charges to county court

CLEARFIELD — Two former volunteer firefighters from the Hope Fire Company in Philipsburg who were recently accused of arson waived their right to preliminary hearings before District Judge Richard Ireland at centralized court held at the Clearfield County Jail.

Samuel W. Connor, 19, of Howard is charged with burglary, conspiracy/arson-intent to destroy unoccupied building; arson-intent to destroy unoccupied building; reckless burning or exploding-places uninhabited or unoccupied structure; possess explosive/incendiary material; criminal mischief, failure to control/duty and recklessly endangering another person.

Clearfield County

Hunter T. Harris, 21, of Philipsburg is charged with burglary, two counts of conspiracy/arson-intent to destroy unoccupied building; reckless burning or exploding-places uninhabited or unoccupied structure; possess explosive/incendiary material; criminal mischief, failure to control/duty and recklessly endangering another person.

According to the affidavit of probable cause, Harris and Connor along with Kenneth L Moore IV, 20, of Lanse, were all volunteer firefighters with the Hope Fire Company in Philipsburg. The three of them allegedly were at the fire station early in the morning Oct. 9 when they discussed setting a vacant house on fire in an effort to respond to it with the fire company and extinguish the fire.

The three allegedly gathered hay, a cardboard toilet paper tube, paper wrapper from a new roll of toilet paper, and a paper plate and made a fuel package for ignition.

Moore drove to the area of the vacant home at 309 Ida St. and dropped off Harris and Connor. Harris placed the fuel package in a wooden frame shed that was attached to the rear of the structure.

Harris then used a lighter from Moore's vehicle to

Make-A-Wish campaign raises more than \$108,000

DuBOIS — DuBois area residents made the 22nd Annual Make-A-Wish Light Up A Child's Life Campaign last week a success by raising slightly more than \$108,000, according to Lindsey Herzing, regional manager of Make-A-Wish, based in Punxsutawney. That amount represents a new record for the annual campaign.

The Greater Pennsylvania Chapter grants more than 700 wishes a year.

"It was such a heartwarming week with many donors and families stopping by to tell their stories," Herzing said. "The community was so generous to this year's campaign."

The annual fundraising campaign for Make-A-Wish was held Dec. 8-13.

Once again, the DuBois Area School District was a big supporter of the campaign. Collectively, the school raised more than \$25,000, Herzing said.

The Greater Pennsylvania Chapter grants more than 700 wishes a year. The Punxsutawney region covers Clearfield, Jefferson, Elk, Cameron, Potter, McKean, Centre, Clinton, Huntington, Blair and Indiana counties.

Make-A-Wish is a wish-granting organization that raises money, not a fund-raising organization that grants wishes.

The "goal" has always been to have enough money to fulfill every wish the organization needs to fill. Make-A-Wish just never wants to

have to turn down a child.

Anyone can recommend a child, from friends and family members to church members, nurses, doctors or volunteers.

When a child is referred, Make-A-Wish makes sure the family is aware the child has been referred and approves.

Then the agency works with doctors to have a form filled out confirming the child has a lifethreatening medical condition.

A team of volunteers is then set up to go to the home and find out what the child dreams of.

The wish can be for anything, but about half of them are to go to Disney World.

Others have included a trip to Hawaii, a cruise, shopping sprees, meeting celebrities, playhouses and swimming pools.

Sometimes the wishes are of something a little more unique, such as being a superhero for a day.

Make-A-Wish volunteers get a first and second wish from the child in case the first wish falls through.

When it comes to trips, Make-A-Wish allows anyone living in the home up to age 18 and the parents to go along.

The average cost for a wish is \$3,900. The average was \$3,400 when wishes began being granted in 1980, but costs have risen.

The Light Up A Child's Life campaign is the only internal campaign the organization does. Sometimes other organizations raise money for Make-A-Wish or students do senior projects that benefit the agency.
