BANDON - Police are appealing to the public for help after someone brazenly shot out a window of Bandon's police station.

Oregon State Police report that at least one round pierced a window of police headquarters at 555 U.S. Highway 101. No one was inside at the time.

Police don't know whether the window was targeted intentionally, but "it'd be a pretty odd by-chance circumstance," said OSP's Lt. Gregg Hastings.

A Bandon officer noticed the shotout window in the afternoon of April 7. Two sources told police shots were fired near the police station late that morning.

OSP troopers recovered evidence at the scene, but they are releasing no information at this time.

## **Attorneys** ready for midwife

COQUILLE - An unlicensed Bandon midwife wants only to be treated like others in the medical field, her lawyer asserted in court Monday.

Marcene Rebeck's defense attorney, Laura Fine Moro, repeatedly pushed the idea that the midwife has been unjustly discriminated against because her practice, though legal, is unlicensed in Oregon. Rebeck is charged with negligent homicide and second-degree manslaughter for the

## Man admits to burying dad

#### Police arrested him in Minnesota

PORT ORFORD - The mysterious human remains found buried in a Port Orford trailer park have been tentatively identified as Charles Owen Starks.

Investigators working with the Social Security Administration arrested Starks' son, Corey Theodore Starks, last week in connection with the remains.

Corey Starks, 38, admitted to burying against Starks.

his father beneath a trailer in the Anchor Inn RV Park in March 2010, after the 71-yearold man died of natural causes. Video and bank records show that Starks received around \$50,000 from his father's Social Security checks.

The Curry County Sheriff's Office has issued a warrant for Starks for second-degree abuse of a corpse.

Police continue to investigate the cause of death and the body's identity. They have not ruled out further charges

Associated reported that U.S. Attorney Amanda Marshall said in a government motion Starks should be detained as a flight risk. Acquaintances quoted in the motion reportedly described Starks as "paranoid" and "unstable."

The Associated Press also reported that Starks will have a May court date in Oregon.

The human remains were discovered March 11 by a maintenance crew refurbishing the Anchor Inn RV Park.

**Local lakes:** This week's trout stockings in several local lakes should bring out plenty of anglers this weekend. The weather has kept lake temperatures in the lower 50s and trout fishing has been good. Look for the trout bite to get better this weekend with more sunshine in the We are still forecast. receiving good reports from anglers fishing from the new boat launch pier out at Bradley Lake. The newly stocked trout tend to hang around the boat launch area before dispersing throughout the lake. Casting spinners or fishing bait under a bobber or off the lake bottom have all been successful methods from the pier.

Local angler Bob Gates told me he hooked and landed a nice rainbow while slow-trolling a white wolly bugger fly. Slow trolling flies or wedding ring spinners tipped with night crawlers, are two local favorite methods to fish Bradley Lake from a boat. Next week, Empire Lakes in Coos Bay is scheduled to receive an additional 8,500 legal-size rainbow trout. So far this season, Emprie Lakes has received 24,000 legal size and 1,000 trophy size trout.

Local rivers: Anglers fishing the lower Rogue River for spring salmon had a decent weekend as river conditions dropped into near excellent condition. Bank anglers plunking bait between Huntley Bar and Quasatana Creek took a few nice fish. Boat anglers are hooking up near Elephant Rock and slots up river. Local guide Rick Howard, 541-740-4986, has been landing fish and plans on spending lots of time on the lower

Rogue. With the season just getting started, anglers have plenty of time to book a trip

with Rick. Reedsport area guide Bob Cobb, 541-271-3850, has been giving us weekly reports on spring salmon fishing on the Umpqua River.

Fishing was fair to good last weekend with a couple of fish in the 30-pound range being caught near low water bridge. Lots of boats anchored up from Scottsburg up to Elkton. Fishing should pick up this week with river levels dropping into perfect condition.

Pacific Ocean, bays and **beaches**: Ocean conditions have been rough, and most sport boats were in port along the South Coast last weekend. Look for condi-

tions to improve this coming weekend, giving anglers an opportunity to get back out bottomfishing and Chinook salmon fishing.

Anglers are still reporting decent rock fishing inside the bay near Charleston. One angler reported catching a mixed bag of black, copper and greenling rock fish.

Next Tuesday, ODFW angler education instruc-

Crabbing in Coos Bay picked up a bit last weekend as well. One boat reported catching a limit of Dungeness near Charleston in about two

Clammers reported catching nice limits of local bay clams up in Coos Bay last week. Some of the lowest tides so far this year will be coming up at the end of April, which is good news for razor clam diggers. Right now the entire Oregon coast is open for harvesting clams and mussels.

#### Find creative solutions

Over a year ago, I stated publicly that I hated politics. I still do. But what I hate even more is that our county has been rendered impoverished by the undue influences of outside forces, and it can and will likely get worse unless we challenge said outside forces.

For the past year, I have been involved with the local community-based nonprofit Coos County Today, which has been leading the opposition to the U.S. Fish & Wildlife's plan to expand the Bandon Marsh. I got involved because the threat to agriculture in our little valley of Coquille is real and very dangerous. Yet, even more than that, the expansion effort represents a threat to our ability to have the choice to live here.

Recently I had the privilege of attending a "work session" held by Rep. DeFazio, wherein I learned of the appalling condition of our local ports, some of which are beyond desperate for dredging services. The message I heard very clearly is that the Army Corps of Engineers has very little, if any, money for dredging any of the ports along our Oregon coastline, and it is not just Oregon, it is a nationwide problem.

The apparent abundance of money available to purchase and convert prime agriculture land to wetlands, while ports are starved for regular maintenance, is a crime. It appears a double economic whammy: Rob our county, yet again, of its ability to create revenue, this time through both farming and fishing.

I have a deep and abiding love for this valley, for the people who live here, and I am passionate that we be able to live here because we choose to do so. That will not happen if we do not step up to the plate and take charge.



#### Issues deserve notice

Three items are pulsing palpably in our county.

One is the cross on the Vietnam memorial in Mingus Park. I will buy lunch for the first objector who can show me where in the U.S. Constitution, or its amendments, it suggests or mandates separation of church and state; it is not there. The Constitution does not demand separation of church and state. This separation is a tenet of revisionist

Another issue is the National Defense Authorization Act, a military spending bill being updated in 2013. On Tuesday April 2, Tom McKirgan, Coos County Oath Keeper and Shane Ozbun, Eugene, presented to the county commissioners a well-outlined presentation of the perils contained in that bill. The NDAA contains language that allows the military to seize American citizens, on American soil, without charging them with anything, to detain them without representation and even to ship them out of the country.

Commissioner Melissa Cribbins questioned whether this should be handled at the state level. This might happen, in time, but the county is the domain of the sheriff and this is where a sheriff can draw the line, telling the feds to go home.

And then there was an administrator, or two administrators? Two is what the recent Portland State University report recommended. Do you recall that only months ago you voted down having an administrator? Well, they're advertising a chief financial officer. Commissioner Cribbins said last week that two applications had already come

This is an unelected administrative position paying between \$4,000 and \$7,000 a month, unaccountable to the voters and serving solely at the pleasure of the commissioners.

To make this even better, a gentleman suggested that the other administrator might be someone hired to oversee the four newly realigned county department groupings. Wonderful! Then we'd have an unelected, unaccountable administrator over elected officials. It could happen.

#### Musical misperceptions

I was saddened as I read the perceptions of local business presented by musician Robert Jump in a recent letter. It is unfortunate that wages for nearly all aspects of the arts are typically low. However, accusing local businesses of "abusing" musicians and seeing them as "nothing more than another window dressing to be had at no cost" is a bit unjustified. Additionally, drawing the conclusion that music should be "expensed" by a business, as a "vital part of the total service businesses offer customers," neglects to examine large aspects of the total business, community, artist and event relationship.

Having been on all sides of the aisle, I can attest to the complexity of the problem at hand.

First, hosting events usually adds costs to daily business activity. While chambers and nonprofits operate with much volunteer assistance, most businesses do not. Hosting special engagements means providing space and employee time, in addition to extra advertising costs. Second, there are costs incurred by business, i.e. rent, liability insurance, utilities, etc., that performers don't have to bear, as well as an undervalued reciprocity factor, publicity, that occurs when a business provides

a venue. These factors equate to a dollar value largely unconsidered by artists, yet always on the minds of business owners.

External perceptions aside, businesses quite often see value in networking with artists, as both a means to create enriching community experiences and to promote tourism. While every business likely hopes inviting performers will add to their customer count and bottom line, that doesn't always happen. The value of this type of activity may be less easily perceived and quantified. Musicians and other cultural contributors are not taken for granted. However, we might also consider whether we take our businesses for

In stating his personal frustrations, Mr. Jump has illuminated a larger societal assumption that businesses are the only entities receiving value in return for the work extended by others. If viewed from a different angle, we might ask, "Why should we worry about benefiting local businesses?" Quite simply, in addition to the opportunities businesses provide, such as jobs, showcasing local talents, etc. we often forget that each is composed of individuals who live in our communities and also need support day to day. Our business owners are usually extremely generous members of society, constantly tasked with donating to local projects.

Beyond dollar contributions, these individuals also donate dozens of hours as they volunteer to develop economic revitalization organizations, such as the Oregon Main Street program. Now soundly under way in Coos Bay/North Bend, Bandon, Port Orford and many other nearby towns, these Main Street groups are focused on strengthening our communities, including arts and performance opportunities. The other perspective: It's not always about what you think businesses should do, rather what they already do and how you can keep your businesses doing what they do, for

Port General Manager Gina Dearth explained that before the box is welded shut, it will be purged with dry argon gas to help prevent oxidation or acidic reaction within the con-

"We're told this is a specialized process that's used in the food, chemical, cryogenic and pharmaceutical industries," she said. "According to the manufacturer, the contents of our capsule will last virtually forever."

Public submissions, which must be limited in size due to the container's capacity, should be intended to inform people in 2113 about Bandon's culture in

"Or it could be advice or a small heirloom that you wish you could give to your great-great-grandchildren," Dearth said. "We encourage photographs or other paper items, like poems or drawings."

Small artifacts, family heirlooms or heirloom seeds will likely be accommodated. CD's and DVD's may meet space requirements if they're not submitted in overwhelming numbers.

The port doesn't plan to police political or religious ideas if they meet space requirements.

"You could submit a copy of a menu from your favorite restaurant, a family historical record or the scorecard from the best golf round of your life," Dearth said.

possibilities Other include labels from a favorite food or beverage, recipes, maps, toys, coins, business cards or agates. Photo possibilities might include autos, grandchildren, scenics or group shots like a graduating class, service club, professional group, commission, board, a business with its staff posed out front, police, municipal group, firefighters or others.

An engraved brass plaque with the port's name, date of burying and opening instructions will be affixed to the capsule, which will be registered with the International Time Capsule Society at Oglethorpe University in Atlanta, Ga. It is to be opened on Sept. 14, 2113.

"Use your imagination in deciding what to submit, and please join us and enjoy cake and help us celebrate the port's centennial on Sept. 14," Dearth added.


