## NOTICE OF PROPOSED PROJECT

On March 18, 2014, Empire Pipeline, Inc. ("Empire") and National Fuel Gas Supply Corporation ("Supply") (collectively known as "National Fuel") filed a joint application with the Federal Energy Regulation Commission ("FERC") at Docket No. CP14-112-000 for authorization to construct approximately 17.12 miles of natural gas pipeline, including 16.35 miles of 12-inch diameter pipeline and 0.77 miles of 16-inch pipeline, and interconnection facilities along with construction of additional compression at Supply's existing Tuscarora Compressor Station. In addition, Empire has requested authorization to rewheel its existing compressors at its Oakfield Compressor Station. The project, known as the "Tuscarora Lateral Project," will consist of the following: the construction of approximately 17.12 miles of new steel pipeline beginning at the southern terminus of the existing Empire Pipeline in Jackson Township, PA, running northwesterly though the Towns of Caton, Lindley and Tuscarora, NY; the addition of approximately 1,384 horsepower ("HP") of compressor Station in the Town of Oakfield, NY. The proposed pipeline route and the location of the compressor stations are shown on the attached map.

The Tuscarora Lateral Project will serve to connect existing natural gas storage capacity on Supply's system with the existing Empire Pipeline system, allowing Empire to offer load balancing storage services to its customers, including Rochester Gas and Electric Corporation. Subject to receipt of FERC authorization, Empire plans to begin construction activities in Fall/Winter 2014 and complete the project in November 2015. Prior to that time, Empire will be in contact with owners of property along the proposed pipeline route regarding the acquisition of rights-of-way or other agreements authorizing the construction, operation, and maintenance of the proposed facilities.

Residents have the opportunity to review National Fuel's application, to submit comments on the application to FERC and to participate as a party in the proceeding by filing for intervenor status. The FERC pamphlet entitled "An Interstate Natural Gas Facility on My Land? What Do I Need to Know?" provides information about FERC's certification process.
