PERMITTED products of Aquatic origin for internment by Tourists from any country

Human Consumption	Fresh fish in any presentation (whole, cut into fillet, or in pieces), frozen or on ice.	Properly packaged for personal consumption, in an adequate ice chest with coolants and/or ice without leaks or spillage.
Human Consumption	Fish in any form (whole, fillet or in pieces), dried, freeze-dried, cooked or smoked.	Properly packaged for personal consumption. No signs of decomposition, no evidence of pests.
Human Consumption	Canned or bottled fish (patè, mussels, etc.)	Label must indicate the type of fish used, expiration date or the preferred date of consumption.
Human Consumption	Fish products in other forms (sauces, meal, deep fried, etc.)	Prepared food ready for human consumption.
Human Consumption	Squid, octopus, conch, sea cucumber and oysters; fresh in any form (whole, cut into fillet or in pieces), frozen or on ice	Properly packaged for personal consumption, in an adequate ice chest with coolants and/or ice without leaking or spillage.

Use	Merchandise	Requirements and Specifications
Human Consumption	Flour or semolina of vegetable origin	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Nuts, almonds and hazelnuts without shell	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Toasted peanuts or pistachios	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Dried fruit and legumes	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Dried herbs and spices	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Cooked vegetables	Must be factory packaged and labeled in a legible language to determine the country of origin. Products that are homemade are not permitted.
Human Consumption	Roasted coffee	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Smoking tobacco	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Yerba Mate or ground herb	Must be factory packaged and labeled in a legible language to determine the country of origin.
Human Consumption	Products and subproducts of processed vegetables	Must be factory packaged and labeled in a legible language to determine the country of origin. Products that are homemade are not permitted.

**PROHIBITED Products of Animal Origin for Internment by Tourists
from any country**

Use	Merchandise	Specifications
Human Consumption	Cheese Butter Cream Yoghurt Liquid pasteurized or UHT, condensed and/or maternal milk	All fresh cheeses are prohibited for internment. All products home or farm made are prohibited. Any products from countries that do not meet the requirements set by the MCRZI are prohibited.
Human Consumption	Fresh, refrigerated or frozen bovine (beef) meat	Internment is prohibited.
Human Consumption	Fresh, refrigerated or frozen pork meat	Internment is prohibited.
Human Consumption	Fresh, refrigerated or frozen poultry	Internment is prohibited.
Human Consumption	Egg	Internment is prohibited.
Human Consumption	Campero chickens from Central America	Internment is prohibited.
Human Consumption	Homemade food products	Internment is prohibited.

Human Consumption	All dried or fresh crustaceans in any form (whole, tail, legs, etc.)	Internment is prohibited.
Animal Consumption	Fish in any form (whole, cut into fillet, or in pieces) frozen or on ice	Internment is prohibited.
Animal Consumption	Dried, freeze-dried, cooked or smoked fish in any form (whole, cut into fillet, or in pieces)	Internment is prohibited.
Animal Consumption	Fish products in other forms (sauces, meal, deep fried, etc.)	Internment is prohibited.
Animal Consumption	Squid, octopus, conch, sea cucumber and oysters; fresh in any form (whole, cut into fillet or in pieces), frozen or on ice	Internment is prohibited.

Human	Dirt or soil.	Internment is prohibited.
Human	Hay, straw; for packaging, adornments, bedding material similar to that for animals.	Internment is prohibited.
Human	Vegetative Material for planting (seeds, bulbs, saplings, etc.).	Internment is prohibited.
Human	Plants and cut flowers.	Internment is prohibited.
Human Consumption	Dry cereals and grains (beans, rice, corn, etc.).	Internment is prohibited.
Human Consumption	Fresh fruit and vegetables.	Internment is prohibited.
