**NOTICE OF BAR DATE AND
INSTRUCTIONS FOR FILING PROOF OF CLAIM**

NOTICE IS HEREBY GIVEN THAT, on or about November 28, 2023, the Delaware Court of Chancery appointed Henry E. Gallagher, Jr. to serve as the Liquidating Trustee (the “Liquidating Trustee”) for Muabessac LLC, a Delaware limited liability company (“Muabessac” or the “LLC”), for the purposes of the dissolving and winding up the LLC, and has further determined that the LLC should be terminated and dissolved.

The Liquidating Trustee now holds certain funds (the “Remaining LLC Funds”), and title to certain parcels of real property (together with the Remaining LLC Funds, the “Remaining LLC Assets”). The Liquidating Trustee intends to oversee the disposition of the Remaining LLC Assets.

Consistent with the Order of the Court, the Liquidating Trustee is directed to take reasonable steps to wind down the LLC’s affairs in an orderly manner and satisfy the claims of its creditors and, where appropriate, other stakeholders. The only assets are the Remaining LLC Assets that are available to satisfy the LLC’s obligations to the extent sufficient to do so. These funds will be applied and distributed in satisfaction of the LLC’s debts and liabilities to creditors in the order of priority provided by any operative agreement and applicable law.

IF YOU BELIEVE YOU MAY HAVE A CLAIM AGAINST THE LLC, THE COURT HAS ESTABLISHED May 1, 2026 AS THE DATE (THE “BAR DATE”) BY WHICH YOU MUST PROVIDE NOTICE TO THE LIQUIDATING TRUSTEE AS TO SUCH CLAIM. IF YOU WISH TO PROVIDE NOTICE AS TO SUCH CLAIM, YOU MUST FIRST CONTACT THE LIQUIDATING TRUSTEE TO RECEIVE A PROOF OF CLAIM FORM. UPON TIMELY RECEIPT OF ANY SUCH NOTICE, THE LIQUIDATING TRUSTEE WILL EVALUATE THE MERITS OF SUCH CLAIM AND MAY SEEK ADDITIONAL INFORMATION IN SUPPORT OF SUCH CLAIM. ANY CLAIM NOTICES SHALL BE DEEMED TIMELY IF RECEIVED ON OR BEFORE THE BAR DATE AT THE FOLLOWING ADDRESS AND/OR EMAIL ADDRESS:

ANY CREDITOR OR CLAIMANT WHO FAILS TO PROVIDE NOTICE TO THE LIQUIDATING TRUSTEE OF A POTENTIAL CLAIM ON OR BEFORE THE BAR DATE, WILL BE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM ASSERTING SUCH CLAIM AGAINST MUABESSAC LLC, AND THE HOLDER OF SUCH CLAIM SHALL NOT BE PERMITTED TO PARTICIPATE IN ANY DISTRIBUTION ON ACCOUNT OF SUCH CLAIM OR TO RECEIVE FURTHER NOTICES REGARDING SUCH CLAIM.
