  - Completed and signed FBN Order Agreement
  - Copy of your FBN statement with the Registrar-Recorder's bar codes\*\*\*
  - Payment make check payable to "The Argonaut" or provide credit card info on order form.

\*\*\*IMPORTANT NOTE: Your FBN statement must have been filed with the LA County Registrar-Recorder/County Clerk not more than 30 days from the 1st date of publication. Look at the top right corner of the statement. If the date above the barcode is less than 30 days from the 1st publication date, it's OK to submit. If the filing date is more than 30 days prior, the statement is no longer valid for publication and you will have to refile your statement with the RR/CC. Please do not send copies of FBN statements that have not been registered by RR/CC. We are will not publish FBN statements that do not have the RR/County Clerk's bar code and stamp.
