Measurements:

The policy should have items such as drug and alcohol use, texting and cell phone use, seat belt use, obeying motor vehicle operation laws, what to do in the case of a accident and vehicle maintenance and upkeep responsibilities. There were 2 drivers with less than 1 years driving experience and 1 was still in training for their CDL.

Employee Exposure:

There were 6 authorized drivers. The probability was rated as low because most drivers were experienced and had training from previous jobs. The severity was rated as death for the reasonably predictable type of injury from truck crashes that could include roll over.

Ty King, manager stated that they don't have a safe driver policy and that most of those things are common sense things to do.

Employees are required to drive with a licensed CDL driver throughout the course of their training. Employees were allowed to drive without that supervision.

Measurements:

The driver involved in the accident held a Class A Commercial Learner Permit. The vehicle was a dump truck with a load of concrete chunks. The road traveled was a narrow, winding, dirt and gravel with sharp drop offs on each side. Vehicle speed was approximately 15-20 mph.

Employee Exposure:

There was 1 employee. Probability was rated as low for the rated of travel on the road and number of employees. Severity was rated a death for the reasonably predictable type of injury from a vehicle roll-over accident.

Ty King, manager said at the time the employee only had a learner permit as he failed his last exam.

Brief Description of Accident: The employee was driving a dump truck on a gravel/dirt road parallel to the irrigation canal. The opposite side of the road sloped down and away. As the truck traveled the road, the shoulder on the down slope side gave way under the passenger side tires causing the truck to slide off the road and then roll over. The driver was ejected from the truck and was struck by the truck causing fatal injuries.

What the Company Does: Vale Oregon Irrigation District provides water for residential and agricultural needs in the region around Vale, Oregon through open canals, buried pipes, storage reservoirs, flow control valves and gates. There were approximately 11 employees.

Description of the Accident: Johnathon Harrison, ditch rider/truck driver and Zach Marks, truck driver were assigned to the task of delivering chunks of waste concrete up to the canal road past Birch Road, to help stabilize the side of the canal. Mr. Harrison and Mr. Marks performed their daily vehicle inspections and then set out together in separated dump trucks to pick-up their first load of concrete chunks that would be taken to the site in their dump trucks. The canal had a few narrow sections where two vehicles could not pass each other, therefore; one truck would go to the site and dump while the other truck only went in partway and then waited for the other truck to come past. Mr. Harrison was driving the lead truck and was traveling the canal road to drop off another load of concrete when for unknown reasons his truck slowly veered off the right side of the road and onto the soft shoulder of the canal road. The dump truck continued off the shoulder of the road and as it slid down the slope the truck rolled over one and one half times. Mr. Harrison who was not wearing a seat belt, fell out of the driver's seat and was ejected from the cab through the passenger side window, where he was pinned by the truck.

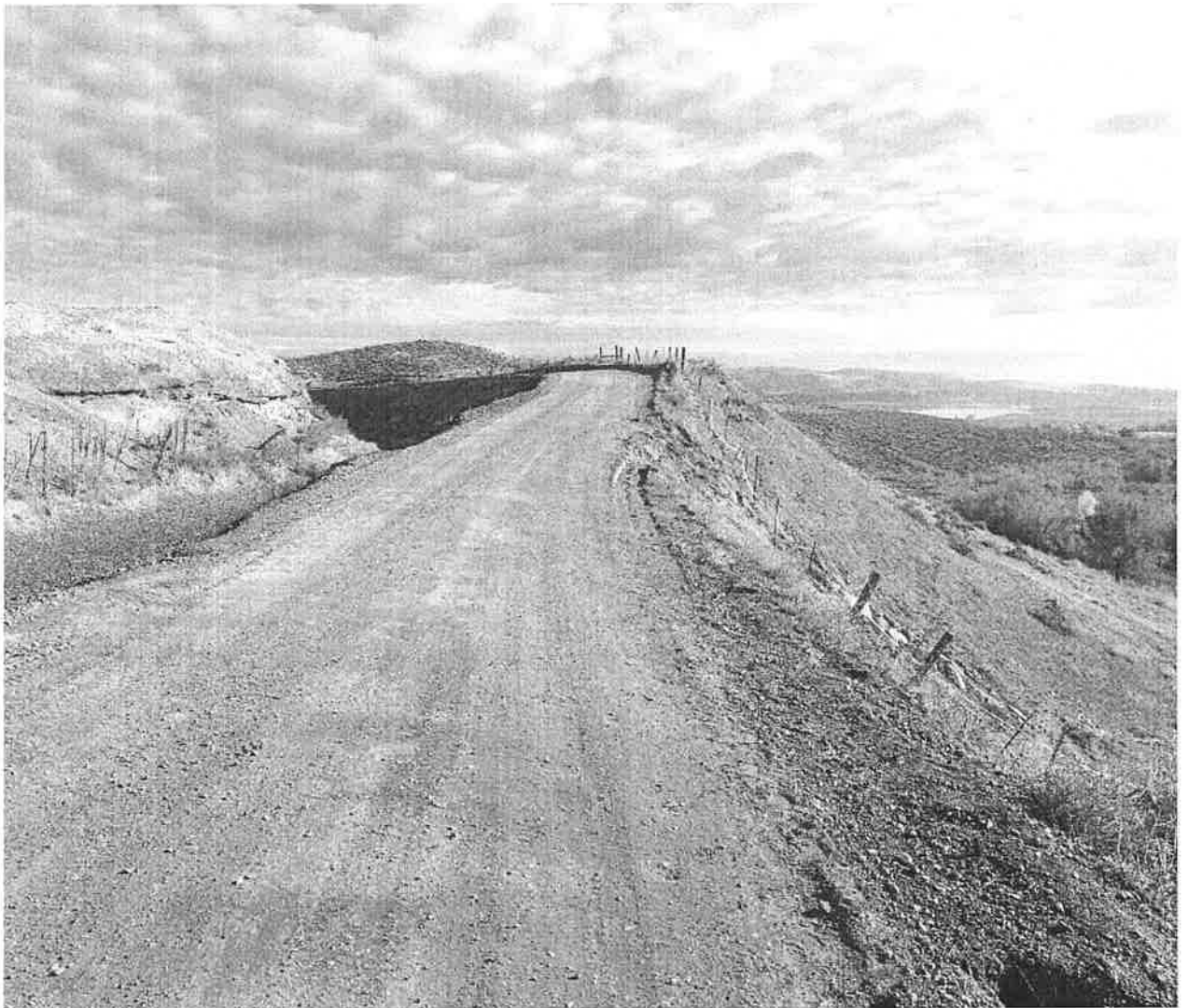
Post Accident Activities: Mr. Marks was returning with another load of concrete chunks in his dump truck and was going to stop at the waiting area for Mr. Harrison to pass before taking his load to the dump location. As he approached the waiting area, Mr. Marks saw the dump truck that Mr. Harrison had been driving, laying on its side at the bottom of a short hill. Mr. Marks parked his truck and ran to where Mr. Harrison's truck was and looked for Mr. Harrison. He found him pinned under the truck, called his name, shook his leg and then checked for a pulse but did not find a pulse. With no cell reception down at the truck, Mr. Marks went back up to his truck and called 911 and the office. EMS arrived and after checking on Mr. Harrison determined he was deceased.

Findings and Justifications:

- 1) Johnathon Harrison, ditch rider/truck driver had worked for Vale Oregon Irrigation District for approximately 2 years.
- 2) The Safety Compliance Officer (SCO) through an interview with Ty King, Manager, found that Mr. Harrison and Mr. Marks had been delivering gravel and concrete chunks for about 3 weeks to various locations along the canal road to build up the banks of the canal (which is dry this time of year). The gravel/concrete was picked up/loaded into their trucks at a site on Graham Blvd in Vale. The SCO drove the route from pick-up location to a central drop off location and found the distance to be from 8 to 10 miles for a round trip. The SCO found posted speed limits of 35 MPH on the paved roads with no posted speed limit on the private gravel/dirt road along the canal.
- 3) The SCO interviewed Mr. King and Mr. Marks regarding the canal road surface/condition and the normal speed at which the truck drove on the road. Both Mr. King and Mr. Marks said the road was in good condition, fairly smooth for a dirt/gravel road, there were a few single lane width areas where 2 trucks could not pass but they worked that out using their radios and as for the speed driven, Mr. Marks said he drove around 10 to 15 miles per hour and believed that Mr. Harrison did also based on watching him as he drove towards him while he waited for him to pass at one of the wide spot locations.
- 4) The SCO asked Mr. King about their "Safe Driver Policies" and Mr. King said he did not think they had one. The SCO asked about driver seat belt use and how they enforce it. Mr. King stated that seat belt use should be common sense and they did not have a means to check for use. The SCO contacted Jessi Hansen, Human Resources Director and requested documents for the inspection. The SCO requested a copy of their "Safe Driver Policy" or any policies regarding operating motor vehicles and Ms. Hansen replied by email that they did not have any. - 5) In reviewing the inspection documents provided by Ms. Hansen, the SCO noted that the copy of the drivers license for Mr. Harrison was a "Commercial Learner Permit" (class A). The SCO noted that on the permit it states that they must be accompanied by a driver at least 21 years old, with a valid CDL and endorsements for the type of vehicle driven at the time of the accident. The SCO checked with Ms. Hansen and confirmed that Mr. Harrison only had a "Learner Permit".
- 6) The SCO reviewed the Malheur County Sheriff's report and noted their observation which said "Based on the tire tracks, the truck appeared to gradually veer to the right towards the edge over a distance of approximately 60 feet. The right side appeared to begin to sink as it got closer to the edge until it tipped over sideways". The SCO calculated that the truck traveled the 60 feet in 2-3 seconds if travel speed was between 15-20 miles per hour. In image IMG 2222.JPG travel path can be seen as off center and then fading to the right due to possible distraction.



- 7) The SCO noted that Mr. Harrison's cell phone was given to the Oregon State Police reconstruction team to determine if it was in use at the time of the accident. The SCO is waiting for a copy of the report (due out after the first of the year).
- 8) The SCO found that Vale Oregon Irrigation District had no safe driver policies in place and that Mr. Harrison was operating a vehicle he was not licensed to operate without in cab supervision by a licensed CDL holder of at least 21 years of age.

Penalty/Violation:

OAR 437-002-2224(4)(b): The employer did not require employees to comply with all applicable seatbelt and traffic safety laws: This was rated as low/death with a civil penalty of \$1400 after adjustment for size.
