#### COUNT ONE

## [18 U.S.C. §§ 2261A(2)(A), (B), 2261(b)(5)]

Beginning on or about October 2020, and continuing to at 1. least on or about July 10, 2022, in Los Angeles County, within the Central District of California, and elsewhere, defendant KIERNAN MAJOR, with the intent to harass and intimidate Victim 1, used an interactive computer service, an electronic communication service, an electronic communication system of interstate commerce, and other facilities of interstate and foreign commerce, namely, cellular telephone networks, email, interstate wires, and the Internet, to engage in a course of conduct, described in paragraph 2 below, that

placed Victim 1 in reasonable fear of death and serious bodily injury to Victim 1 and immediate family members of Victim 1, and that caused, attempted to cause, and would reasonably be expected to cause substantial emotional distress to Victim 1 and immediate family members of Victim 1.

- 2. Defendant MAJOR's course of conduct included, among other things, the following:
- a. On or about April 25, 2021, defendant MAJOR sent an email to Victim 1 titled "Show dad and his friends" which stated: "I will kill you and mutilate your siblings for years. It's only a matter of time the way you are acting. Please report me ASAP it will help you at least a little."
- b. On or about April 25, 2021, defendant MAJOR sent an email to Victim 1 titled "Re: Show dad and his friends" which stated: "I will kill your family one by one. And then i will have a field day embarrassing your whore parents next week. Lol this is what you get for blocking me. Cunt. [¶] Wait till i target [Victim 1's brother] and [Victim 1's brother] hahaha.. bye."
- c. On or about April 25, 2021, defendant MAJOR sent an email to Victim 1 which stated: im killing you and whoever lives at all the addresses i know you reside at."
- d. On or about May 12, 2021, defendant MAJOR sent an email to Victim 1 titled "Warning" which stated: "[Victim #1], I cannot sustain the suffrage that comes with our dispute at the present moment. It genuinely drives me insane to re-experience the past everyday with counsel, especially in such detail. For these reasons am temporarily choosing to focus on and invest in my own well-being for a change. This message serves only as a purpose to

forewarn you of what is patiently awaiting each and every living specimen of your past, current and future and to update you on the status of your court summons'. The nastiest truth's about all of you will be relentlessly exposed and I will conduct this in such as public manner that it will continue to haunt you guys in every corner of this planet until I finally succeed in your guys' total extinction. You and your father are absolutely terrible people and do not ever attempt to convince yourselves otherwise. This doesn't even scratch the surface of how I feel about you or the 'discomfort' you're all about to experience for the rest of your lives. Good luck to you all :) I almost hope you underestimate me. Count your fucking blessings, -Kiernan"

- e. On or about May 14, 2021, defendant MAJOR sent a series of messages to Victim 1 which stated:
- i. "We have just made our first round of calls to your employers. I wish you a horrible weekend. Please commit suicide sooner rather than later. See ya in court ya slut [¶] You will have to lock me up for life to stop me from going after you, your family and your friends. I am insanely creative and have been prepping this for over a year. Don't ruin your life. I beg you because when you apologize I'll end up feeling really bad. This will destroy your family without question. My last warning. I just feel it's moral to warn you. Sorry to harass."
- ii. "You will always be an entitled little gold digging cunt. You're nothing but a waitress turned glorified nanny. Get over yourself and your fabricated reality. Remember that you have gotten no where in life on your own, neither has anyone in your family. You will never earn shit in your life unless throwing your

pussy at rich men counts. I will expose you and our megalomaniac 1 father. Your time is running thin slut and I will not relent. You can 2 3 think you are making progress but you could own the state of NY and it wouldn't prevent what's to come. Good luck. You'll really need it. 4 Sad you think I'm all talk. Bye." 5 6 f. On or about May 17, 2021, defendant MAJOR sent a 7 series of messages to Victim 1 which stated: 8 i. "Be lucky I don't fucking kill your dad and you. 9 Pussy whore cunt." 10 "Fucking die whore. Pussy ass bitch." ii. 11 iii. "Your homes are about to blasted." 12 iv. "Kill yourselves before I end up doing it." On or about July 31, 2021, defendant MAJOR sent a 13 q. 14 series of messages to Victim 1 which stated: 15 "And if I don't kill him myself, I hope your 16 father dies." 17 ii. "I'll kill all of your family any day. It's just a matter of will. You are the one who begs for hell." 18 19 h. On or about September 21, 2021, defendant MAJOR sent a series of messages to Victim 1 which stated: 20 21 i. "You're a slut and a gold diggin whore and I'll 22 prove it." 23 ii. "If I don't kill someone you know, I'm ll be 24 surprised." 25 iii. "If I see you I'm killing you on the spot" 26 iv. "You're a fucking bitch. A whore cunt bitch and

you'll pay for it."

"I will kill you and your pathetic family" On or about November 23, 2021, defendant MAJOR sent a message to Victim 1 which stated: "I adore how simple it is to get you (and your family) to hang yourselves by your own rope." On or about June 27, 2022, defendant MAJOR sent a j. series of messages to Victim 1 which stated: "I'd say within a year or two someone gets i. brutally hurt over this if things are unchanged. But that's just my quess." ii. "I'm not going anywhere. I will burn your life to the ground if I have to." iii. "You have no real friends don't forget that." iv. "And one day you'll die in front of your kids." On or about July 1, 2022, defendant MAJOR sent a k. series of messages that included the following: i. "I would stay inside this independence day." ii. "I could kill your father in about 30 minutes so relax." iii. "I hope you're dumb enough to ignore this because I'm 200% killing you or someone you know 1" iv. "Without a doubt I will kill someone by Monday." "IM GONNA KILL ALL OF YOU FUCKING BITCHES" V. "When I kill your father what would you like me vi. to use?" vii. "You will never stop me no matter what the fuck you do from killing them now." "And you're whole family about to get viii. murdered tonight for it."

- 3. Beginning on or about May 29, 2022, and continuing to at least on or about July 10, 2022, in Los Angeles County, within the Central District of California, and elsewhere, defendant KIERNAN MAJOR, with the intent to harass and intimidate Victim 2, used an interactive computer service, an electronic communication service, an electronic communication system of interstate commerce, and other facilities of interstate and foreign commerce, namely, cellular telephone networks, email, interstate wires, and the Internet, to engage in a course of conduct, described in paragraph 4 below, that placed Victim 2 in reasonable fear of death and serious bodily injury to Victim 2 and immediate family members of Victim 2, and that caused, attempted to cause, and would reasonably be expected to cause substantial emotional distress to Victim 2 and immediate family members of Victim 2.
- 4. Defendant MAJOR's course of conduct included, among other things, the following:
- a. On or about May 29, 2022, defendant MAJOR sent a series of messages to Victim 2 which stated:
  - i. "I honestly believe you guys want me to die"
- ii. "I PROMISE it someone checks on my welfare I will kill Everyone"
  - b. On or about June 25, 2022, after Victim 2 demanded payment for money she lent defendant MAJOR, defendant MAJOR sent a series of messages to Victim 2 which stated:
- i. "You'll get paid on my terms or you'll get my promises made."

ii. "My 'friends' aren't as nice." 1 iii. "What's your faggot fathers number" 2 3 "You or your bitch ass father can call me. " "I don't make threats I make promises btw." 4 On or about June 27, 2022, defendant MAJOR sent a 5 C. 6 series of messages to Victim 2 which stated: 7 "You've drank too much of [Victim # 1's] Kooli. 8 Aide." 9 ii. "For that expect to suffer life-long consequences along side her until you guys get over yourselves and take your 10 11 fathers cock out of your mouths. And its sad you're naïve enough to believe her. [Victim # 1] IS A LIAR!" 12 iii. "I will fucking find you fuckers and I will 13 14 fucking hold you accountable by whatever means necessary. COUNT THREE

[18 U.S.C. § 875(c)]

On or about May 31, 2021, in Los Angeles County, within the Central District of California, and elsewhere, defendant KIERNAN MAJOR, with intent to issue a threat and with knowledge that it would be viewed as a threat, knowingly transmitted in interstate and foreign commerce a communication containing a true threat to injure the person of another, that is, messages to Victim 1 that included the following: "I'll kill all of your family any day. It's just a matter of will. You are the one who begs for hell."

COUNT FOUR

[18 U.S.C. § 875(c)]

On or about July 1, 2022, in Los Angeles County, within the Central District of California, and elsewhere, defendant KIERNAN MAJOR, with intent to issue a threat and with knowledge that it would be viewed as a threat, knowingly transmitted in interstate and foreign commerce a communication containing a true threat to injure the person of another, that is, text messages to Victim 1 that included the following: "I hope you're dumb enough to ignore this because I'm 200% killing you or someone you know [. . .] IM GONNA KILL ALL OF YOU FUCKING BITCHES [. . .] ON FUCKING GOD I WILL KILL YOU."

COUNT FIVE

2 [18 U.S.C. § 875(c)]

On or about July 10, 2022, in Los Angeles County, within the Central District of California, and elsewhere, defendant KIERNAN MAJOR, with intent to issue a threat and with knowledge that it would be viewed as a threat, knowingly transmitted in interstate and foreign commerce a communication containing a true threat to injure the person of another, that is, an email to Victim 1 with the following in the subject line: "I 100% WILL SCALP YOUR FATHER ALIVE."

1 COUNT SIX

2 [18 U.S.C. § 875(c)]

On or about June 27, 2022, in Los Angeles County, within the Central District of California, and elsewhere, defendant KIERNAN MAJOR, with intent to issue a threat and with knowledge that it would be viewed as a threat, knowingly transmitted in interstate and foreign commerce a communication containing a true threat to injure the person of another, that is, messages to Victim 2 that included the following: "MEET WITH ME AND BE EVEN [. . .] Or fucking DIE [. . .] And I mean DIE."
