

BRAVE RAIN FOR VOTES

Suffragists Address Crowds in Street During Storm.

ASK WOMEN TO JOIN THEM

Miss Helen Todd and Miss Jeannette Rankin Relate Experiences in Other Campaigns and Outline Purposes of Present One—Mrs. Glendower Evans Says Fair Sex Can Improve Society.

The equal suffrage demonstration, which has been in progress since the arrival in Washington Thursday of suffrage delegates from all over the country to urge the submission by the Senate of an equal suffrage amendment to the Constitution, was made last night by three suffrage meetings, two of which were in the street. The street meetings were effective, to judge from the manner in which the speakers were received by the crowds, despite the rain which fell on them.

Miss Helen Todd, of Chicago and San Francisco, who was one of the principal factors in the victory of the suffragists in California, addressed a meeting at Fifteenth and Pennsylvania avenue. She told the experiences encountered by the suffragists in the California campaign, and declared that every woman, could she bring herself to look beyond her environment, would join in the demand for the vote, in order to help rectify conditions affecting women and children in the slums and factories.

Miss Rankin Speaks in Rain.

Miss Jeannette Rankin, who figured prominently in the suffrage campaign in Montana, addressed a meeting at Seventh and Pennsylvania avenue, and outlined the purpose of the suffragists in seeking action by Congress. The friendly attitude of the crowd was evidenced when one man gave his umbrella to a woman. Miss Rankin, as she continued to speak in the rain, said:

Mrs. Glendower Evans, of Boston, noted for her work for child labor legislation in Massachusetts, addressed a meeting at the Covenant Tent, Laramie street and Franklin avenue. She spoke on the importance of the vote to women, that they may lend their political power to bringing about the desired changes in social and economic conditions.

WRECK TIES UP ORE PLANT.

Two Men Killed, and Dockmen, Blaming Crews, Quit Work.

Superior, Wis., Aug. 1.—Alleging that bitter feeling between the train crews and the men working on the ore docks, most of whom are foreigners, is to blame for a wreck last night between two ore trains, in which two men were killed, one man probably fatally hurt, and five others injured, the dockmen quit last night and today have refused to go to work, and the big Allouez plant of the Great Northern Railway is tied up.

The suspension of work, with the consequent interruption of the railroad operations, delays at the mines, and to the boats in the ore trade, entails a loss of \$100,000 a day, according to railroad officials.

The switchmen on duty last night, it is said, disappeared and have not since reported.

PARIS—**WANTS PRINCE TO PAY**

C. B. Wood to Fly From New York to Washington to Test Army Machine.

New York, Aug. 1.—Records promise to shatter next Tuesday by C. Murvin Wood, a Moisant aviator, who will drive a Moisant, a 190-horsepower, with a Pennsylvania Railroad special train between New York and Washington.

Wood will give a demonstration in Washington before the State, War, and Navy departments, to show the possibility of his flying across the Atlantic. He will carry a letter to Maj. Edgar Russell, of the signal corps, at Washington, from Maj. Gen. Thomas Barry, of the department of the East. The special train will carry army and navy officials and others interested in aeronautics.

PARIS—**EXPRESS RATES CUT DOWN**

California State Board Orders 15 Per Cent Reduction.

Charges That Southern Pacific Sacrifices Undue Part of Its Earnings in Payments to Wells-Fargo Company.

San Francisco, Aug. 1.—The State railroad commission of California ordered reductions today in the express rates of the Wells-Fargo company amounting to a cut of 15 per cent, or \$50,000 from present annual revenues. Every rate of the company in this State is abolished by order, which is effective October 1, and more than 3,000,000 new rates are ordered, effective at that time.

The express company is ordered to operate six months on the commission's rates and to submit a statement of earnings, and if it feels the rates are not justified, the findings pronounce the company a "partner" in the monopoly.

The commission finds a sidelight on the question in the intercorporate relationship between railroads and the express company, which is that the express company is not responsible for the express service upon both the railroads and the public.

As the conditions of work vary on the different roads, the managers cannot undertake to settle the disputes points, they announced, until more data are available as to the operation of the award on the individual roads.

The body will be taken to Charlestown, W. Va., for the funeral and burial. Mr. Tuwiler guarded John Brown 16 nights in the old jail at Clarksburg.

Tuwiler resided at Harper's Ferry. He leaves three sons and two daughters.

AT WORK ON SHAKE-UP

Public Printer Ford Outlines His Efficiency Plans.

NONE BUT GOOD ONES TO STAY

Print Shop the Best in the World, He Declares, but Still Thinks There Is Room for Improvement—Democrats to Have Preference Where They Show Equal Ability.

There is going to be a shake-up in the government printing office, and it will be just as extensive, says Public Printer Cornelius Ford, as he considers necessary to place the office on the highest possible basis. He outlined his plan yesterday, that any wholesale reorganization for the purpose of elevating the Democrats in the office is contemplated.

"This office is reputed to be one of the most efficient printing organizations in the world," said Mr. Ford, "but we have little room for improvement. I shall scan all reports closely and keep a strict watch upon all branches of the work. Wherever I find that a change will increase the efficiency of a department, I will make it, regardless of political affiliations. I have no power political ax to grind here. I simply want efficiency with economy, and there will be some changes."

Democrats First Choice.

"Everything else being equal, Democrats will be given the preference. There can be no criticism of that. For department heads and others upon whose fidelity I must depend to successfully administer this office, I shall naturally favor Democrats, with entire confidence, however, the prime consideration regardless of politics."

In the changes thus far made, W. T. Herbig, a Democrat, has succeeded Howard G. Geary, Republican, as day manager of the monotype section. J. A. Arnold, Democrat, has succeeded William Bechert, politics not ascertained, as night foreman of the monotype section. Both Gale and Bechert have been assigned to lower positions.

Capt. Chisholm Promoted.

Capt. Daniel V. Chisholm, a Democrat, who has been employed in the government printing office for more than 21 years, has been promoted to night manager of the office. He is the second man to take the place left vacant by the resignation of John R. Berg. Capt. Chisholm has worked in all departments of the office. He was an assistant of the First Battalion, District of Columbia Volunteers, and took part in the fall of Santiago. He is also a deputy post master of the Odd Fellows and a Scottish Rite Mason.

Joseph P. O'Loane assumed his duties yesterday as private secretary to the public relations committee of the House.

Mr. O'Loane, a Democrat, was appointed to the post by Mr. Ford, just as rapidly as he is able to singe out those employees who are not producing the required results.

SHAKE-UP ALARMS CLERKS.

Employees of Agriculture Bureaus Expect More Dismissals.
