Dear Jecyn:

This letter follows up our phone conversation of this morning regarding the Gallatin Historical Society ("GHS") and an appraisal relative to the Save America's Treasures Grant application ("SAT"). The County has stated that it will require the GHS to obtain an appraisal prior to a vote on whether to proceed with the grant application, and has cited several statutes in support of this requirement. Those statutes are MCA 7-8-2202, 2211, 2214 and 2216.

On their face the statues do not support the County's appraisal requirement. MCA 7-8-2202 clearly states that an appraisal is required when the County is going to <u>purchase</u> a conservation easement. In this case the County would be granting an easement, not purchasing one. MCA 7-8-2211 addresses the sale or exchange of County property. In this instance there is no sale or exchange, but merely the granting of an easement of finite duration. Both MCA 7-8-2214 and 2217 also relate to the sale of property which is not the case here.

There is also the issue of what kind of appraisal the County is requiring. Is it a simple appraisal of the building that can be performed by a local appraiser? Is it a business valuation appraisal? Is it an appraisal of the building's historic value relative to a conservation easement? All we've been told is that the GHC must "get an appraisal." Please clarify specifically the type of appraisal required and the information the County is hoping to gain from it.

You indicated that the County is adamant about the appraisal requirement despite the fact that the statutes do not support it. Depending on the type of appraisal, the requirement may onerous for the GHS, as we have learned that there are no licensed conservation easement appraisers in Montana, and the cost would likely exceed \$10,000. If the County insists on that type of appraisal, the GHS will likely be unable to pursue this excellent SAT grant opportunity.
