

For Mondays discussion and if pushed for an acceptable agency option .

My recommendation -- maintain <u>all</u> public rights of ways across the Schlueter property and re-route (at landowners expense) the west leg of 166B road. This would shift it away from Mr. Schlueters home site, on a mutually acceptable location, and re-connect it south of his home back into 166B.

This would protect the publics access rights across the property while providing the landowner security and privacy around his primary home site. Also we could consider hunting, camping and campfire restriction on 166 B/D roads thru section 21 if additional security is required.

This seems like a simple & fair solution to a complex issue. It also might not require a lot of lands work to complete other than reassignment of re-routed road, engineering of road re-route and possibly a forest order. This was an action which has been displayed to Stan and was an acceptable alternative we considered in March 2009 too.



I called Brian Kuehl on Sept 28 AM, per Mary's request.

Brian said he was pleased to know Mary will meet on Monday Sept 28th @ 0930, in the SO.

Brian is coming to Bozeman Sunday pm and will meet w GVLT (local land trust) Director Stephen Johnson @ 0900.

I will summarize other comments from Brian below:

Brian said he is continuing to look for a solution that the FS can support and is in the public interest.
