AFFIDAVIT AND ORDER  
RE: PROBABLE CAUSE/COMPLAINT

V.

**Ok Nan Tenette (DOB 12/26/1942)**

Defendant

The undersigned, being duly sworn, states as follows:

1. I, Justin Sharp am a sworn officer with the Belgrade Police Department, City of Belgrade, Gallatin County, Montana.

2. On **July 29, 2013** the defendant was arrested for the charge(s) of:

Promoting Prostitution, a felony, (MCA 45-5-602)

3. The undersigned believes that there is probable cause to charge the defendant with said charge(s) because:

On July 24, 2013, Detective Sergeant Lensing and I met with CI975, hereafter referred to as CI, regarding his interactions with masseuses at the Beijing Spa. Your affiant is aware that CI has worked as a confidential informant for law enforcement in the past and has provided credible information.

CI told your affiant that he has personal knowledge of illegal activities occurring at the VIP Spa (107 South Broadway, Belgrade Montana). CI advised your affiant that the current masseuse at the VIP spa propositioned him for sexual acts in exchange for monetary compensation when she worked at a different massage parlor. CI further advised your affiant that he was told, during his interactions with the masseuse, that one hundred (100) dollars got

"anything you wanted." CI indicated that he took this to mean that the masseuse would engage in sexual intercourse for the sum of one hundred (100) dollars. CI told your affiant that he is aware that the VIP Spa offers "full bath" services, which involves the client being completely nude and the masseuse bathing the client.

CI told your affiant that he did not know the name of this masseuse however, he described her as being a Chinese female who was in her late 40s. He further stated that the female had a more slender build and had black hair but was known to change her appearance. It should be noted that, Ok Nan Tenette, an employee of the business who was identified by her California Driver's License, is much older than 40 years of age, she appears much younger and could be mistaken from someone in her late 40's. The remainder of CI's description accurately describes Tenette.

On July 26, 2013, I applied for and was granted a legal search warrant to record the conversations and interactions between CI and the employees of the VIP Spa.

On July 29, 2013, I was monitoring the audio transmitting device when CI entered the business. CI later relayed the following information to me regarding the contact. Tenette and a second female, who was later identified as Yu-Sun Gasperi, proceeded to engage CI in a massage. Eventually Tenette gestured as if she was performing a "hand job." CI declined the sexual contact but proceeded to negotiate with Tenette to engage in sexual intercourse in exchange for one hundred and twenty (120) dollars. CI provided the money to Tenette and she exited the room.

Sergeant Lensing and I entered the business and made contact with Tenette and Gasperi in the lobby of the business. Both Tenette and Gasperi were placed under arrest. The building was then secured.


I applied for and was granted a legal search warrant for the business. At approximately 1800 hours I returned to the business to execute the search warrant. During the course of the search I located two distinct living quarters that contained personal items, toiletries, bedding, and changes of clothing. I also located a kitchen that was fully stocked with food and cooking supplies.

The first living quarter was in the easternmost massage room. In this room I located prescription medication for Gasperi and several receipts for food and other household items. The second living quarters was located in the southeast most room. In this room I located prescription medication for Tenette. I also located

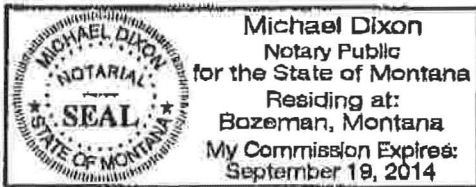
condoms hidden in the area around the front desk and used condoms in a garbage can in the kitchen area. I located the money CI provided, hidden between pages of books on the front counter.


The VIP Spa is a prostitution business. Tenette solicited one hundred and twenty (120) dollars from CI in exchange for sexual intercourse and took the money from CI after the deal had been made. Tenette was living in the business as was evident by the living quarters that contained her personal belongings. Tenette has been charged with promoting prostitution, a felony, for knowingly living in a prostitution business. Tenette was transported to the Gallatin County Detention Center where she was held without bond.
