

NOTICE TO BIDDERS

Sealed proposals will be received by the City of Bryan at the office of the Clerk-Treasurer, 1399 E. High Street, Bryan, OH, until 12:00 p.m. local time, on Wednesday, March 11, 2026 and at that time and place will be publicly opened and read aloud. Said proposals shall be for the project known as "2026 Asphalt Program".

Each proposal must contain the full name of every person or company interested in the same, a notarized non-collusion clause and must be accompanied by a Bid Guaranty in the form of either:

1. A bond for the full amount of the bid in substantially the same form as that document which is part of the bid packet and designated as "SURETY BID BOND AND PERFORMANCE BOND" OR
2. A bond for 10% of the amount of the bid in substantially the same form as that document which is part of the bid packet and designated as the "TEN PERCENT (10%) BID GUARANTY" OR
3. A certified check, cashier's check, or letter of credit issued pursuant to Chapter 1305 of the Ohio Revised Code, attached to the bid document in substantially the same form as the "TEN PERCENT (10%) BID GUARANTY." The amount of the certified check, cashier's check, or letter of credit shall be equal to 10% of the bid. Any letter of credit is revocable only at the option of the City.

All bid guaranties shall be payable to the City of Bryan for the benefit of the City of Bryan. All bonds shall be issued by a surety company authorized to do business in the State of Ohio as a surety and shall be approved by the City Clerk-Treasurer. All certified checks, cashier's checks, or letters of credit shall be made payable to the City of Bryan.

No bidder may withdraw his bid for a period of thirty (30) days after the scheduled time for receiving bids.

Only ODOT prequalified contractors are eligible to submit bids for this project.

The successful bidder shall pay each worker employed by said contractor and cause all subcontractor(s), or other person(s) about or upon the public work, to pay at least the minimum prevailing wage rates on this City of Bryan, Williams County, public improvement as determined by the Ohio Department of Commerce Division of Industrial Compliance, Bureau of Wage and Hour Administration. (ORC 4115.06).

The CONTRACTOR shall promptly comply and cause all subcontractors to promptly comply with all state and federal laws regarding drug-free workplace.

The Council of the City of Bryan, Ohio reserves the right to reject any and/or all bids and to waive any irregularities in the bidding. Bid sheets, plans and specifications may be obtained from the City of Bryan Engineering Office, 1399 E. High St., Bryan, OH. Each set shall include one set of drawings and one project manual.

All bids must be signed and submitted on the blanks which are bound in the bid documents. All bidders must obtain original plans and specifications from the City of Bryan and must be registered as a plan holder with the City and submit bids on original complete bid books. Bids must state the unit prices on the blanks provided and be enclosed in a sealed envelope marked - 2026 Asphalt Program - and be addressed to John W.
