Has we the detainee of the above detention center is hereby seeking help in this matter. has this as now become unbearable and inhuman to say the lease. As some individual have now been in detention over 10 months without a court date. Some waiting for a change of venue that is now over 5 months. No due process even the detainees with legal status and no felony or Aggravate Felony or still subject to the same standard. has one of the GEO staff has made clear We are all getting Deported so we just need to shut up. Some detainee that are here for traffic tickets no crime and came to the united States legally. Fathers last their child and is unable to go the funeral. We have detainee in here trying to Kill themselves in lure of dealing with the inhumane condition their are facing. Some detainee is yet to see their detention office after 10 months of been detained. Family been put out of their homes because the bread winner is in detention. Mothers and Daughters are now doing unbelievable things to make ends meet and help their mother. Family's are been put out on the Street's. Kids can't go to School We have detainee with restaurant, construction company. that's having closed their doors. Individual 82 years of age in Wheel chair. Individual that's been order release Still detained. We have lawyers taking detainee money then telling them they can't help them. Some not even showing for court cases after taking any where from \$5,000 to \$8,000. Some detainee will sit in a holding Cell for 5 to 6 hours then sent back with out seeing the judge. We are sometime given only 1 or 2 days to get ready for court hearing And with out clear instruction as to what is needed.

Judges are having detainees file forms that there are not going to approve and after any where from \$1,600 to \$2,000 its denied. This is with more that Half of the detainee's in here. We're facing emotional and psychological Distress from this prolonged and unconstitutional detention.. see Id 8 U.S.C.1231. Does not permits indefinite detention.

THIS IS JUST TO NAME A FEW THINGS THAT'S HAPPENING ON THIS END. WE NEED HELP PLEASE SHARE THIS WITH OTHERS. THIS IS THE UNITED STATES OF AMERICA. THE LAND OF THE FREE AND THE HOME OF THE BRAVE WITH LIBERTY AND JUSTICE FOR ALL.

1. The food is not fitting to serve to animal. Uncooked Chicken, Brown salad, old Eggs, uncooked rice.
2. We will go weeks without medical care after making a request one have to lay on the ground first.
3. The court will put of your Court date back 3 to 6 months even with an attorney.
4. Our Legal mail is coming per open from GEO staff that's coming from outside Courts every day.
5. We are having our outgoing mail open by GEO staff. Some mail not making it to its destination.
6. we are have our mail willfully delayed going out and coming in that we are missing deadline to reply
7. We are treated when we speak out about anything that's wrong. To be put in the Hole.
8. we will go for 5 to 6 hours with out water and when we get it it has hair In it and taste disgusting
9. Has we are unable to go out. How is so much DRUGS coming in and form whom? Afraid to say
10. We have detainee now trying to kill then self form what they are having to deal with in here.
11. Has now(16) detainee has died in Adelanto center how much more will before Changes are made?
12. Called HANDICAP, GAY, ACCUSED OF SLEEPING WITH EACH OTHER DETAINEE BY GEO STAFF.
13. Detainee getting deported with out any due process of law. Are court date.
