

**NOTICE OF 30-DAY PUBLIC REVIEW**  
**CITY OF CHINO HILLS**  
**COMMUNITY DEVELOPMENT BLOCK GRANT 2019-2020 ACTION PLAN DRAFT**

**NOTICE IS HEREBY GIVEN** that the City of Chino Hills has prepared its draft One-Year Action Plan 2019-2020 for the Community Development Block Grant Program (CDBG).

The publication of this notice is the beginning of the 30-day public review period required under Federal Regulation 24 CFR 91.105(b)(2). The public review and written comment period begins April 15, 2019 and ends May 14, 2019.

**NOTICE IS HEREBY FURTHER GIVEN** that the One-Year Action Plan will be presented to the City Council for approval on May 14, 2019 at 7:00 p.m. in the City Council Chambers located at 14000 City Center Drive, Chino Hills, CA 91709.

At this meeting, the City Council will receive public comment on the draft One-Year Action Plan 2019-2020 and approved 30-day review, with the intent to submit the One-Year Action Plan 2019-2020 to the Department of Housing and Urban Development (HUD).

During 2019-2020, the City of Chino Hills will receive an **estimated** amount of \$376,000 in CDBG Funds. Pursuant to federal regulations, every CDBG activity must meet the requirements for one of the national objectives: benefit low and moderate-income persons; prevent or eliminate slum or blight; or meet an urgent need that poses a serious or immediate threat to the health or welfare of the community.

To receive these funds, the City of Chino Hills is required to submit to HUD a One-Year Action Plan. The One-Year Action Plan provides detailed information regarding the priorities and expenditures of the CDBG program.

For the fiscal year beginning July 1, 2019 and ending June 30, 2020, the City of Chino Hills proposes the utilization of CDBG funds to implement the programs listed below:

In addition, approximately \$42,330 of prior year unexpended carryover funds will be available for the City's Home Improvement Grant Program (HIGP).
