STATE OF OKLAHOMA, COUNTY OF ROGERS:

I, Scott E. Pruitt, the undersigned Attorney General, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Rogers and in the State of Oklahoma, George Edker Thomas did then and there unlawfully, willfully, and knowingly commit the crime(s) of:

- Count 1: HARASSMENT BY TELEPHONE OR OTHER ELECTRONIC COMMUNICATION— a MISDEMEANOR, on or about the 4th day of May, 2013, without justifiable or excusable cause, by means of telecommunication or other electronic device willfully made comments to Aubrey Michelle Higgins which were obscene, lewd, lascivious, filthy, or indecent by texting her in such a manner that caused said

Aubrey Michelle Higgins to feel frightened, intimidated, threatened, harassed or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 2: HARASSMENT BY TELEPHONE OR OTHER ELECTRONIC COMMUNICATION— a MISDEMEANOR, on or about the 29th day of October, 2013, without justifiable or excusable cause, by means of telecommunication or other electronic device willfully made comments to Kristopher Scott Higgins which were obscene, lewd, lascivious, filthy, or indecent by texting him 19 times on this date which were obscene, lewd, lascivious, filthy or indecent in a manner that caused said Kris Higgins to feel frightened, intimidated, threatened, harassed or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 3: STALKING – a MISDEMEANOR, on or about the 6th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Aubrey Michelle Higgins by sending text messages stating “Who is Tippy?” sixty times on this date, in a manner that caused said Aubrey Michelle Higgins to feel frightened, intimidated, threatened, harassed, or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 4: STALKING – a MISDEMEANOR, on or about the 6th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Kathryn Higgins by sending approximately thirty-five (35) text messages on this date, in a manner that caused said Kathryn Higgins to feel frightened, intimidated, threatened, harassed, or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 5: STALKING – a MISDEMEANOR, on or about the 7th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Kathryn Higgins by sending approximately twenty-four (24) text messages on this date, in a manner that caused said Kathryn Higgins to feel frightened, intimidated, threatened, harassed, or molested;

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 6: STALKING – a MISDEMEANOR, on or about the 8th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Kathryn Higgins by sending approximately nineteen (19) text messages on this date, in a manner that caused said Kathryn Higgins to feel frightened, intimidated, threatened, harassed, or molested;

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 7: STALKING – a MISDEMEANOR, on or about the 9th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Kathryn Higgins by sending approximately four (4) text messages on this date, in a manner that caused said Kathryn Higgins to feel frightened, intimidated, threatened, harassed, or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 8: STALKING – a MISDEMEANOR, on or about the 12th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Kathryn Higgins by sending approximately thirteen (13) text messages on this date, in a manner that caused said Kathryn Higgins to feel frightened, intimidated, threatened, harassed, or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 9: STALKING – a MISDEMEANOR, on or about the 13 day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Kathryn Higgins by sending approximately eighty-two (82) text messages on this date, in a manner that caused said Kathryn Higgins to feel frightened, intimidated, threatened, harassed, or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 10: STALKING – a MISDEMEANOR, on or about the 13th day of May, 2013, by willfully, maliciously, and repeatedly texting or harassing one Aubrey Higgins by sending text 34 messages on this date in a manner that caused said Aubrey Michelle Higgins to feel frightened, intimidated, threatened, harassed, or molested.


This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.

Count 11: HARASSMENT BY TELEPHONE OR OTHER ELECTRONIC COMMUNICATION– a MISDEMEANOR, on or about the 29th day of October, 2013, without justifiable or excusable cause, by means of telecommunication or other electronic device willfully made comments to Aubrey Michelle Higgins which were obscene, lewd, lascivious, filthy, or indecent by texting her 20 times on this date in a manner that caused said Aubrey Michelle Higgins to feel frightened, intimidated, threatened, harassed or molested.

This Crime is punishable by a fine of up to \$1000, or imprisonment for up to 1 year, or both.
