Count Six Aggravated Vehicular Assault - F4

§2903.08(A)(2)(b)

Defendants Sanford D. Doss**Date of Offense** On or about March 30, 2019*The grand jurors, on their oaths, further find that the Defendant(s) unlawfully*

while operating or participating in the operation of a motor vehicle, cause serious physical harm to David Caraballo, recklessly.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Seven Driving While Under the Influence - M1

§4511.19(A)(1)(a)

Defendants Sanford D. Doss**Date of Offense** On or about March 30, 2019*The grand jurors, on their oaths, further find that the Defendant(s) unlawfully*

did operate any vehicle, streetcar, or trackless trolley within this state, when at the time of the operation he was under the influence of alcohol, a drug of abuse, or a combination of them.

FURTHERMORE, and he within ten years of the offense, previously has been convicted of or pleaded guilty to one violation of division (A) or (B) of this section or one other equivalent offense to wit: (1) on or about 4/11/14, case #2013TRC09187, in the Auglaize County Municipal Court, in violation of 4511.19(A)(1).

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Eight Driving While Under the Influence - M1

§4511.19(A)(1)(g)

Defendants Sanford D. Doss**Date of Offense** On or about March 30, 2019*The grand jurors, on their oaths, further find that the Defendant(s) unlawfully*

did operate any vehicle, streetcar, or trackless trolley within this state, when at the time of the operation he has a concentration of two hundred four-thousandths of one per cent or more by weight per unit volume of alcohol in his blood serum or plasma.

FURTHERMORE, and he within ten years of the offense, previously has been convicted of or pleaded guilty to one violation of division (A) or (B) of this section or one other equivalent offense to wit: (1) on or about 4/11/14, case #2013TRC09187, in the Auglaize County Municipal Court, in violation of 4511.19(A)(1).

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.
