Dear Honorable Prime Minister Benjamin Netanyahu,

We would like to take this time to congratulate you on the milestone anniversary of seven decades of the Israeli Bonds organization. This program for the Jewish State has become an economic cornerstone for the land of ancient heritage and modern achievement.

First and foremost, as clergy from multiple denominations across the Buckeye Bible Belt, we want to express our profound regret regarding a 2017 World Council of Churches' (WCC) policy. This policy calls Israel's sovereignty of Jerusalem, Judea, and Samaria "illegal" and the expansion of its construction and settlements as "illegal and unjust." (1) This same policy states its support of the Boycott, Divestment and Sanction (BDS) Movement in Jewish settlements of these listed areas.

We want to assure you Mr. Prime Minister, the World Council of Churches does not represent our local congregations nor does its unorthodox view on Israel carry any authority.

There is no doubt, despite the BDS Movement, Israel has proven to be resilient. In fact, the State of Ohio is known as the largest state holder (2) of Israel bonds in the United States. Recently at the request of the faith community, one of our local counties invested in Israel bonds for its first time.

In addition, clergy in our region have gone on record supporting U.S. recognition of Jerusalem as the Israeli capital, (3) and supporting Israeli sovereignty of the Golan Heights, Judea, and Samaria. (4)

**Having said this, as clergy from thirty-two (32) congregations in North Central Ohio, we are declaring our commitment to the Jewish State by personally purchasing Israel bonds. We want to formally express our support for Israel and to demonstrate our approval of the construction and expansion of Jewish settlements in its sovereign territories.**

As Deuteronomy 32:49 says, this is the land G-d is giving as your own possession.

We believe there is a dynamic bridge between Ohio and Israel. Together we are combatting anti-Semitism and building a brighter future. Thank you for your friendship.
