ON 6/15/2018 AT AROUND 1329 HOURS MYSELF AND OFFICER TOKMENKO WERE DISPATCHED TO [REDACTED] FOR A SUSPICION CALL. UPON ARRIVAL WE MET WITH THE CALLER, ANNA SCHULGASSER. ANNA SCHULGASSER STATED THAT ON 5/21/2018 THEIR FAMILY WENT TO THE HERSH FAMILY RESIDENCE (3762 BAINBRIDGE) FOR LUNCH. ANNA SCHULGASSER STATED [REDACTED] AND THE HERSH CHILDREN WERE PLAYING OUTSIDE TOGETHER AND THAT AKIVA MEIR HERSH TOOK ALL THE CHILDREN TO THE PARK TO PLAY. ANNA SCHULGASSER STATED THAT ON THE WAY HOME SHE ASKED [REDACTED], WHAT [REDACTED] AND MR. HERSH TALKED ABOUT WHILE AT THE PARK. ANNA SCHULGASSER STATED THAT [REDACTED] SAID THE FOLLOWING: [REDACTED] AND MR. HERSH WERE PLANNING A TRIP TO TEXAS TO VISIT THE ALAMO AND OTHER HISTORIC SITES. MR. HERSH SAID THAT [REDACTED] SHOULD NOT ASK [REDACTED] PARENTS FOR PERMISSION AND THAT MR. HERSH WOULD THINK OF THE BEST WAY TO ASK [REDACTED] SO THEY WOULDN'T SAY NO. ANNA SCHULGASSER STATED THAT SHE THEN ASKED [REDACTED] IF EVERYONE WAS GOING ON SAID TRIP [REDACTED] FAMILY AND THE HERSH FAMILY) BUT THAT [REDACTED] WAS CLEAR THAT IT WOULD JUST BE [REDACTED] AND MR. HERSH. ANNA SCHULGASSER STATED THAT SHE TOLD [REDACTED] A TRIP LIKE THIS IS EXPENSIVE AND THAT [REDACTED] REPLIED THAT MR. HERSH TOLD [REDACTED] "WHAT'S MONEY BETWEEN FRIENDS." ANNA SCHULGASSER STATED THIS WAS A STRANGE STORY THAT RAISED A LOT OF RED FLAGS TO HER AND HER HUSBAND.



ANNA SCHULGASSER STATED THAT SHE THEN TOLD [REDACTED] TO STAY AWAY FROM MR. HERSH WHEN [REDACTED] ADDED TO [REDACTED] STORY STATING THAT MR. HERSH HAD SHOWED [REDACTED] HIS GUNS AT HIS HOUSE. ANNA SCHULGASSER ALSO STATED THAT [REDACTED] TOLD HER THAT MR. HERSH TOLD [REDACTED] NOT TO TELL [REDACTED] PARENTS FOR THEY WOULD BE MAD IF THEY FOUND OUT HE SHOWED [REDACTED] HIS GUNS.

ANNA SCHULGASSER STATED THAT HER AND HER HUSBAND, URI SCHULGASSER, INFORMED THEIR RABBI, AARON LEOVICS, ABOUT THE INCIDENT. ANNA SCHULGASSER STATED THAT THEIR RABBI TOLD HER THAT HE HAS HAD A LOT OF PEOPLE COME TO HIM WITH CONCERNS REGARDING MR. HERSH AND THAT THE RABBI URGED HER TO FILE A POLICE REPORT.

ANNA SCHULGASSER STATED THAT BEFORE THIS INCIDENT OCCURRED THAT SHE THOUGHT MR. HERSH WAS A NORMAL AND NICE PERSON. ANNA SCHULGASSER STATED THAT HER AND HER FAMILY HAS NOT SEEN OR HAD ANY CONTACT WITH MR. HERSH SINCE THIS INCIDENT OCCURRED.

ANNA SCHULGASSER'S HUSBAND, URI SCHULGASSER, WAS RELUCTANT TO LET OFFICERS SPEAK TO [REDACTED] ABOUT THE INCIDENT.

IT SHOULD BE NOTED THAT LATER IN THE DAY ON 6/15/2018 ANOTHER SUSPICION REPORT WAS FILED REGARDING AKIVA HERSH. REFERENCE FILE NUMBER 1802959. BOTH REPORTS WERE FORWARDED TO DETECTIVE PIERSON.

On May 21, 2018 our family went to the Hersh's house for Shavuot (Jewish Holiday) lunch and spent the day there 3762 Bainbridge. The kids, [REDACTED] ran around, Akiva Meir Hersh took them to the park, watched them play out side while Chana Rivka and I talked. On the way home I asked [REDACTED] what [REDACTED] and Mr. Hersh talked about and [REDACTED] told me: [REDACTED] & Mr. Hersh were planning a trip to Texas to visit the Alamo & other historic sites. Mr. Hersh said [REDACTED] shouldn't ask [REDACTED] parents - Mr Hersh would think of the best way to ask so they wouldn't say no. I asked [REDACTED] if we were all going on the trip. or if [REDACTED] was going with Mr. Hersh's family but [REDACTED] was clear that it would just be the two of them →

I said a trip like this is expensive - Mr. Herish said "what's money between friends."

This was a very strange story that raised A LOT of red flags.

After telling [REDACTED] that Mr. Herish is not a grown up they should be around [REDACTED] added that Mr. Herish also showed [REDACTED] is guns (I think this is in the basement office) and said [REDACTED] Daddy would get mad at Mr. Herish if he knew.

I told our therapist when she came, and she said we should not let the [REDACTED] around him, but there was nothing she could report him on. We told our rabbi, Rabbi Aaron Lebovics [REDACTED]. He called me this week to say a lot of people have come to him and that I should file a police report before the weekend.

Before this happened I thought he was a totally normal, nice person. He is very ~~smart~~ charismatic. This all happened right in front and around me.
