ON 6/15/2018 AT AROUND 1702 HOURS, ELY SKORSKI CAME TO THE CLEVELAND HEIGHTS POLICE DEPARTMENT TO FILE A POLICE REPORT. SKORSKI STATED THAT HE BEGAN NOTICING THAT AKIVA HERSH SEEMED TO BE DRAWING [REDACTED] CLOSE TO HIM. ELY SKORSKI STATED THAT HIS FAMILY IS ACQUAINTANCES WITH AKIVA HERSH THROUGH THE JEWISH COMMUNITY. SKORSKI STATED THAT AT ONE POINT HE RECEIVED A PHONE CALL FROM A FRIEND THAT MR. HERSH AND [REDACTED] WERE BOTH HOLDING HANDS IN A WAY THAT SEEMED SUSPICIOUS. SKORSKI THEN STATED THAT HE DISCOVERED [REDACTED] HAD A SECRET CELL PHONE THAT [REDACTED] KEPT HIDDEN. SKORSKI STATED THAT HE DOES NOT KNOW WHERE THE CELL PHONE CAME FROM BUT THAT HE BELIEVES MR. HERSH GAVE [REDACTED] THE CELL PHONE SO THAT THEY CAN COMMUNICATE WITH EACHOTHER. SKORSKI STATED THAT HE DID NOT SEE ANY MATERIAL OR CONVERSATIONS ON THE CELLPHONE FOR THERE WAS NO SIM CARD INSTALLED. SKORSKI STATED THAT HIM AND HIS WIFE SENT MR. HERSH AN EMAIL TELLING HIM TO STAY AWAY FROM THEIR CHILDREN OR THEY WOULD CONTACT THE POLICE. SKORSKI STATED THAT HE HAD LEARNED THROUGH THE COMMUNITY THAT OTHER PARENTS WERE CONCERNED ABOUT MR. HERSH AND THIS IS WHAT PROMPTED HIM TO COME AND FILE A POLICE REPORT. IT SHOULD BE NOTED THAT SKORSKI STATED THAT THE ABOVE INCIDENTS TOOK PLACE OVER THE PAST COUPLE OF YEARS. SKORSKI NO LONGER HAS THE CELL PHONE THAT HE BELIEVES WAS GIVEN TO [REDACTED] FROM MR. HERSH. SKORSKI STATED THAT NEITHER HIM OR HIS FAMILY HAS SEEN OR BEEN IN CONTACT WITH MR. HERSH FOR THE PAST SEVERAL MONTHS.

ANOTHER SUSPICION REPORT WAS TAKEN BY THIS OFFICER REGARDING AKIVA HERSH EARLIER ON THE SAME DAY. REFERENCE FILE 1802954. BOTH REPORTS WERE FORWARDED TO DETECTIVE PIERSON.
