California Department of Transportation, District 4: San Gregorio Creek Bridge Project



NOTICE OF AVAILABILITY of the Draft Initial Study with Proposed Mitigated Negative Declaration/Environmental Assessment (Draft IS/EA), Notice of Intent to Adopt a Mitigated Negative Declaration, virtual public meeting, and in-person open house.

WHAT'S BEING PLANNED

The California Department of Transportation (Caltrans) is proposing seismic restoration of the San Gregorio Creek Bridge (Bridge Number 35-0030) on State Route (SR) 1 (also known as Cabrillo Highway or Highway 1) in unincorporated San Mateo County from post mile (PM) 17.40 to 18.20, just south of SR 84. Alternatives under consideration include retrofitting the existing bridge or replacing the existing bridge with

a new bridge featuring pedestrian and bicycle facilities. The environmental consequences of the project are summarized in the Draft IS/EA.

The project area is not located on a hazardous materials site, as defined by Government Code Section 65962.5 (Cortese List).
