

Official notices were sent out and published in the newspaper and there was one written concern for disruption by a neighboring farmer. Morris read some definitions in the County's land use plan, such as the majority of urban activities are discouraged from being located in the Rural Service Area. Approval of this request would set precedent which may result in the removal of high-quality farmland from production throughout the county. For the reasons stated, this request has been found to be inconsistent with the applicable policies of the Benton County Land Preservation and Use Plan. Erickson stated there shouldn't be any disruption to farming in the area, that he just wanted a peaceful place in the county to call his home. Hearing no other further comments, the public hearing was closed.
