Overview

Pennsylvania's Broadband Equity, Access, and Deployment (BEAD) program is funded pursuant to the Infrastructure Investment and Jobs Act of 2021 which provides more than \$42 billion to expand access to high-speed internet across the United States. Pennsylvania received a total of \$1,161,778,272.41 through its federal allocation. The Pennsylvania Broadband Development Authority (PBDA) is administering the BEAD program in accordance with the National Telecommunications and Information Administration (NTIA)'s [BEAD Restructuring Policy Notice](#) and [Act 96 of 2021](#).
