Public Notice for Elderly Voters of Voters with Disabilities

Any elderly voter with a disability whose polling place is inaccessible may vote early by absentee ballot or at the Election Commission on Election Day.(T.C.A. §2-3-109(e)(1)) If the voter chooses to vote at the election Commission Office on Election Day, they must complete an affidavit at the Election Commission Office no later than Monday, July 27, 2026, stating that their polling place is not accessible.

Photo ID Requirements for All Voters

Federal or Tennessee State Government issued photo ID is required to vote, unless an exception applies. College Student IDs and photo IDs issued by cities, counties, and other states will not be accepted.
