Sealed bids will be received by the City of Ellensburg at the office of the City Clerk at City Hall, 501 N Anderson St, Ellensburg, WA 98926, until **3:00 PM on Tuesday, March 24, 2026**, and will then and there be opened and read for construction of the improvements. Each bid shall be plainly marked "**WASTEWATER TREATMENT FACILITY RECIRCULATION PUMP STATION IMPROVEMENTS – Bid Call #: 2026-07**". All bid proposals shall be accompanied by a bid proposal deposit in a cashier's check or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should the successful bidder fail to enter into such contract and furnish satisfactory performance bond within the time stated in the specifications, the bid proposal deposit shall be forfeited to the City of Ellensburg. The engineer's range for the project is \$1,750,000 to \$2,000,000.

The project consists of furnishing all labor, materials, equipment, and other miscellaneous items to improve return activated scum (RAS) and scum pumping in the existing Recirculation Building, including replacement of two (2) vertical, non-clog, centrifugal RAS pumps, one (1) positive displacement scum pump, with associated piping, valves and appurtenances, electrical work, instrumentation, painting, and demolition. The work includes the replacement of the existing motor control center, the installation of a temporary motor control center, and installation of a network cable between the Recirculation Building and the Administration Building, including coordination with the Owner's Programmer for PLC and OIT programming; and other miscellaneous items necessary to complete this project.
