This letter is the initial agency decision to your 11/25/2020, request under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, submitted to the VHA 671 - South Texas Veterans HCS FOIA Office for copies of the following records:

We would like an accounting of all positive COVID-19 tests of residents and staff of the Kerrville Veterans Affairs Medical Center in Kerrville, Texas. We believe in the public interest and public safety of our community it is relevant that the community should understand how many veterans have been sickened by COVID-19, in what units it has spread and how many residents have been transferred to the San Antonio area, because they could not be cared for in Kerrville. We also request confirmation on the number of fatalities involving veterans at the medical center from or from complications related to COVID-19.

The Quality Management Service, and the Occupational Health Clinic physician conducted a search for data responsive to your request. The search was conducted by utilizing the search criteria as outlined in your request. At the conclusion of the search, the following information was determined to be responsive to your request.

Re: the number of all positive COVID-19 test of residents and staff.

- 1) Residents- 12
- 2) Staff 13

Re: how many residents have been transferred to the San Antonio area, because they could not be cared for in Kerrville – 12

Re: number of fatalities - 4

All information is provided in its entirety. No portions of the requested records have been withheld either in whole or in part. This concludes VHA 671 - South Texas Veterans HCS's response to your FOIA request.
