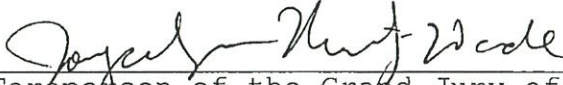
19 I, the undersigned, say, on information and belief, that in

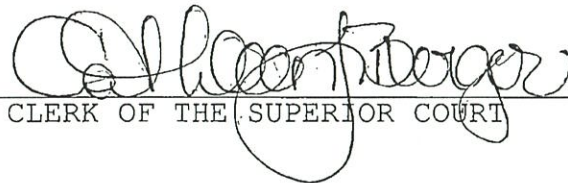

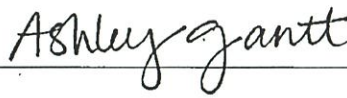
