I, the undersigned, say, on information and belief, that in
the County of Yolo, State of California:

Count 1 : On or about April 1, 2025 through April 3, 2025,
JOANNA CLARA SODKE and CHLOE LOVE PETERSON did commit a FELONY,
namely, a violation of Section 182(a)(1) of the California Penal
Code, CONSPIRACY TO COMMIT A MISDEMEANOR, in that JOANNA CLARA
SODKE and CHLOE LOVE PETERSON did willfully and unlawfully
conspire with another or others to commit a misdemeanor
violation of Section 405 of the California Penal Code, and
there did occur in furtherance of said conspiracy the following
OVERT ACT(S):

- 1) Unidentified Co-Conspirators posted fliers at University of California at Davis which contained, among other things, the words "BLOCK THE FASH", "BLOCK THE TRASH", "MASK UP, COME TOGETHER & BLOCK THE FASH TRASH", "THE UNIVERSITY IS HOSTING TPUSA ON APRIL 3RD AT THE QUAD @ NOON", "WEAR MASKS, COVER UP, & NO PEACE POLICING", and "11AM WELLMAN BOWL APRIL 3".
- 2) On April 1, 2025, Unidentified Co-Conspirators posted on Instagram, under a page owned by UC Davis Cops off Campus organization, urging people to "show up on 4/3 at 11am in the Wellman Bowl". "Protect your identity by covering up and wearing a mask" and "There's rain in the forecast, so an umbrella might also be nice."
- 3) On April 3, 2025, Unidentified Co-Conspirators and JOANNA CLARA SODKE and CHLOE LOVE PETERSON joined up with other Unidentified Co-Conspirators to approach Turning Point USA representatives at the UCD quad.
- 4) On April 3, 2025, Unidentified Co-Conspirators and JOANNA CLARA SODKE marched in a group towards representatives of Turning Point USA.
- 5) On April 3, 2025, An Unidentified Co-Conspirator caused the "Make America Great Again" hat from the head of T.B.
- 6) Co-Conspirator CHLOE LOVE PETERSON picked up T.B.'s hat.
- 7) On April 3, 2025, an Unidentified Co-Conspirator threw an object at E.B.
- 8) On April 3, 2025, an Unidentified Co-Conspirator took a sign from E.B.
- 9) On April 3, 2025, Co-Conspirator JOANNA CLARA SODKE

1 punched B.B.

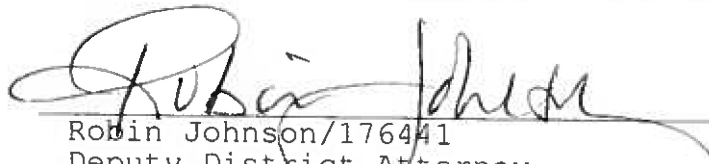
2 10) On April 3, 2025, Unidentified Co-Conspirators
3 destroyed items at the Turning Point USA event.

4 11) On April 3, 2025, Unidentified Co-Conspirators took
5 items from the Turning Point event.

6 Count 2 : On or about April 3, 2025, JOANNA CLARA SODKE
7 and CHLOE LOVE PETERSON did commit a MISDEMEANOR, namely, a
8 violation of Section 242 of the California Penal Code, BATTERY,
9 in that JOANNA CLARA SODKE and CHLOE LOVE PETERSON did willfully
10 and unlawfully use force or violence upon the person of another.

11 I declare under penalty of perjury that the foregoing is
12 correct.
